Preface:

I am one of the people who was very influenced by the Cayce material. I grew up without a very strong spiritual foundation, but with a desire for the truth. Cayce planted the first seeds of doubt in my agnosticism, and I eventually came to some sense of my place in the universe and my connection to the Creator. And while I always gave Cayce his due and felt grateful for his work, the question "Why Cayce" still lingered? With all the billions of people who have come and gone on this planet, why did Cayce have this special gift of omniscience in his dream state?

I never really expected to get an answer to this question, but here I am 30 years later and it seems the answer has fallen into my lap. I've come to conclusions I've never heard anyone else reveal, but I don't believe anyone else has the amazing set of clues that have come to me. This is a story of epic proportions and it has led me to a better understanding of the meaning of life, the way Creation works, who God is, why we are here and where we are going. It includes pieces from separate sources that fit together to complete a vast cosmic puzzle. One of the main pieces of this puzzle is David Wilcock.

I discovered Wilcock's website in the late 2000s.

The site had thousands of pages, somewhat disorganized but extremely fascinating. (Fortunately, his organization is increasing over time.) Beginning on November 10, 1996, Wilcock used established remote viewing protocols, which he then modified to accurately produce verbal statements from the entity that eventually identified itself as "Ra." [Remote viewing protocols are designed to greatly reduce, if not eliminate, the possibility of the conscious mind interfering with the psychic data stream.]

Transcripts of a number of these "readings" have been posted on his site since his inception in February 1999. I have found these readings to show a great breadth of wisdom and at times have documented very accurate predictions of the future well in advance. These future predictions occurred most appropriately in three types of cases:

1. ***Events that affected Wilcock's personal*** life. Wilcock usually had a one to three month gap between the time he dictated his dreams and audio tape readings and the time he transcribed them. No matter how long he waited to transcribe these tapes, in some cases more than six months, the data spoke to the specific events he was experiencing at the time, sometimes even right in the room when the words were written. One notable example occurred when a dream described a building whose

the upper floor was shaped like a UFO with round windows. As he typed these words into the computer from a three-month-old recording while listening through headphones, his friend Sabrina walked into the room and began telling him about a man who had shown her a picture of the exact same building. Wilcock did not remember the dream,

read It was not possible to force Wilcock's data to predict the future, but the vast majority of Wilcock's clients would receive some form of accurate information that confirmed the source's validity. One client woke up from a dream in which he had trouble setting up his camera tripod. He went to the mailbox, found Wilcock's reading tape, went back inside, unwrapped the package and put it in the tape recorder. As the reading began, he heard the words, "I am Ra. The tripod represents..."

3. ***Events that have had a strong effect on mass consciousness***, such as the death of famous personalities, specific earth changes and political developments, such as the Bush/Gore election crisis and the 9/11 attacks exact name, nature, and place of the events were not always specified, but in all cases there is abundant evidence that the event was well understood before it actually occurred.

Unlike many others working in the field, Wilcock was very candid in revealing personal information, including the times when Ra took on the role of Wilcock's wise mentor and spiritual guide, congratulating him on a job well done and chastising him when he failed to meet to certain expectations. Wilcock also offered readings to people for a fee, which would allow Ra to speak directly to an individual's problems.

Another section of Wilcock's website featured a selection of online books he had written that were freely offered to anyone who wanted to download them. One book, "Wanderer Awakening", was autobiographical in nature and detailed many mysterious circumstances in his life before he began reading. The "Convergence" series featured Wilcock's efforts to create a unified model of the Cosmos, assembling and coordinating many anomalous scientific discoveries and astronomical observations to provide scientific confirmation of the existence of God and the ethereal

the energy field that creates and sustains all physical matter. .

Additionally, in the now three-part Convergence series, he has presented solid evidence that our planet is in the midst of a dimensional shift that will culminate sometime around the oft-mentioned year 2012, a date also expressed in the Mayan calendar. [We will hear more about this as we continue.]

And then there is a section of his website called "Edgar Cayce/ Website Overview". In this area, Wilcock presents evidence to support the view that he is the reincarnation of Edgar Cayce. My first impulse was that this was "absurd", but as I began to research the information I noticed extreme similarities in facial appearance, natal astrology, character, purpose and psychic abilities, not to mention the reincarnation of several close people who also had facial and character similarities, it started to make sense. Cayce has often been considered "the most documented psychic of all time".

Similarly, Wilcock documented written transcripts for *each a dream he had, on a daily basis since 1993*, with all of his readings transcribed and added to the mix since 1996. That in itself is a huge personal commitment to one's own psychic work, outside of an enormous scientific effort. Only a small percentage of these dream transcriptions have been published online due to their often very personal content, as well as the fact that there are over 5,000 pages of transcribed material to explore.

I was asked to review some of my old Edgar Cayce books, and the more I researched them, the more parallels emerged. However, Wilcock's readings were decidedly different from Cayce's readings. Wilcock did not openly claim to have the ability to give the exact medical advice he gave Cayce, and Wilcock did not refer to past lives very often. And personally, I've never been attracted to channeled works, aliens and the like.

Yet there was a heavenly wisdom in these readings which, in my opinion, could not have come from Wilcock's own waking consciousness. My curiosity was piqued and I needed to find the truth. I scheduled a reading from Wilcock and later interviewed him for "The Spirit of Ma'at" - a web magazine founded by spiritual teacher Drunval Melchizedek. This book is the result of my research.

When I researched Wilcock, I discovered that no less than Uri Geller, the world-renowned clairvoyant and spoon bender, had also discovered Wilcock and was impressed enough to put a testimonial on his website — www.uri-geller.com :

The Return of the Prophet — Uri Geller

Many believed that the greatest clairvoyant of the last century was Edgar Cayce, who dictated medical remedies to thousands whom he had never met.

Already in this new century, one man claims to have similar abilities. His prophetic dreams and visions seem to reveal a remarkable gift. But the strangest factor of all is . . . this man is Edgar Cayce .

Even in the UFOlogy community, where extreme weirdness is the norm, David Wilcock's claims arouse skepticism and wariness. But this 27-year-old vegan, up-and-coming science fiction writer in the mid-nineties predicted Japan's nuclear meltdown [the accident in early 2000] and the loss of NASA's Mars probes.

Its pages are filled with warnings such as: "Stock Market Crash! Archangel Michael told me, 'Stocks will be devalued so much that it will look like utter nonsense.'" Archangel is specific - the Dow will fall to 2880.30.

It's not just Wilcock's dreams that tell him he's reborn Cayce. It's a mirror image of him: his jaw is slightly less overbite and his earlobes are larger, but otherwise Ed and Dave could be twins.

Cayce, who died in 1945, announced that he would return in 1998. Wilcock says he first associated his own dreams with Cayce's trance in November 1997.

Fortunately, there's enough fascinating and controversial material on the web to make sure you don't have to part with a penny.

The pieces are coming together... and in this book I will share with you the steps I went through and the conclusions I reached in my mission to find out if David Wilcock is in fact the reincarnation of Edgar Cayce. In my research, I drew not only on information from the Wilcock website, but also on a number of books by Edgar Cayce and an individual named Carl Rueckert, who was also a channel for Ra (the same Ra that Wilcock supposedly channels) from 1981 to 1985. I found amazing concordances, which tied all these different sources together. The implications of this intertwining story are staggering... far more far-reaching than I could have ever imagined. And they provide explanations for such previously inexplicable phenomena as cycles of solar activity, the accelerated pace of world events,

Wilcock's second volume in the Convergence series, *Free Energy, Anti Gravity and Extraterrestrial Science*, presents a solid theoretical framework that explains how to build technologies that could dramatically help Earth, including the elimination of all conventional fossil fuel energy sources and the advent of antigravity technology that would suddenly turn humanity into an interstellar species. He then builds on these concepts to help explain the critical connection between consciousness, spirituality, and physics.

Finally, Wilcock's latest work, *The Divine*

Cosmos ambitiously overturns many assumptions of science that have outlived their usefulness, replacing them with a miraculous model that demonstrates how and why our entire solar system is now showing measurable signs of a massive increase in its energy charge. In compiling this new cosmology, Wilcock essentially solved the "Unified Field" theory and others; the true energetic nature of the atom is shown to be identical with

by what we see at all other levels of magnitude, including moons, planets, solar systems, galaxies, living cells, and even the vast structure of the universe itself. In doing so, Wilcock resurrected the ancient, probably Atlantean science of "sacred geometry" and brought it back to the forefront of human consciousness.

I invite you to engage your own investigative skills as I reveal my revelations. I am not presenting any of this as truth. But if there is truth here, it will be revealed to most of us in our own lifetimes, and perhaps this book will better prepare us for what may come and how to deal with it, both survival-wise and spiritually.

Chapter 01: Setting the Scene

Each of us is involved in solving the great cosmic puzzle. Who we are? Why are we here? Why does God allow our world and our lives to be so twisted and unpredictable? Why is love so elusive? Why is there so much injustice? Why do innocent people die? Is man eternal... and if so, where were we before we were born? Where do we go when we die? And why does one not remember? And if we exist forever, why do we fear death?

We go through our lives so busy with daily routines and responsibilities that we usually don't pay attention to these deeper questions until something pulls us out of our unconscious and we're forced to fit another piece into them. puzzle. The pieces of the puzzle usually come in strange, unexpected ways. Something comes along that makes us really happy for a while; a new job, a new love or a new child. Something needs us in life, and this need creates a new value for us, a new understanding. Another piece of the puzzle falls into place. Someone who seems to be happier crosses our path

than most others. They have a long-lasting smile that the sadness of the world won't just fade away.

Someone like Mother Teresa lives an exemplary life different from the rest of us, and we wonder what might motivate her. Someone close to us passes away, or the World Trade Center collapses, and we are faced with the contemplation of our own mortality. We read something that inspires us, from an author who seems to understand the innate workings of our beings and our souls better than we do. Our intuitions are able to recognize the truth even when our conscious mind forgets it.

And then we have the anomaly of living like Edgar Cayce. As we all struggle to find meaning and understanding, as we desperately search for the pieces of our puzzle, we are suddenly presented with an example of a man who has omniscience, *but only in sleep!* He's a man who can know and diagnose what's bothering someone else when they're thousands of miles away... a man who can potentially have the right answer to any question possible... a man who can look into the past lives of anyone who he asks. And yet he is also a man who in his waking state is not unlike you or me, a man who has his own weaknesses, confusions and challenges.

With hundreds of books written about Edgar Cayce readings and millions of people reading them, Cayce has helped many of us add a new piece to our puzzles. Despite the empty state of our memory banks, Cayce gave those who became acquainted with his work the confidence to believe that they had lived before and that life would continue after the death of the body. But the question remains: *why Cayce?*

With all the billions of people who have walked this planet, why was Cayce able to have this awareness, even if only in sleep, while the rest of us walk in our somnambulistic waking trance? These are the questions I hope to answer in the course of this book.

And here is another point. We are presented with so much information in our lives, how can we know what to believe? We have at least three tools at our disposal to recognize the truth of something:

1. **Personal verification.** If I told you that there was a sale going on at the supermarket and you went there and bought some food at a discounted price, you would have personally confirmed my story.
2. **Credibility of the source.** How reliable has the source been in providing reliable data in the past?
3. **Intuitive recognition.** Sometimes things just feel good. Something is true. Later, a person may have a personal experience that confirms the initial intuitive knowledge that was originally accepted on faith.

In telling the story of Edgar Cayce's reincarnation, I will draw credibility from a number of sources. If it weren't for all the amazing parallels between so many totally disconnected pieces of the puzzle, I'd have a hard time believing it myself. So I ask you to suspend your own beliefs and judgments until you finish the whole book and then see if it all fits together. The implications will go far beyond the reincarnation of Edgar Cayce; we are talking about a course of events that, if indeed true, will affect every form of life on our planet within the next decade.

Since this year, 2002, it has become increasingly evident that the world is changing at breakneck speed, with political unrest, geophysical unrest, terrorist activities, financial instability, solar flares, and epidemics such as AIDS. Edgar Cayce's predictions painted a very similar portrait of these times some 70 years ago. At the same time, we can see a continued increase in spiritual awareness, empathic connection, and the reaching out of ordinary people everywhere for peace, tolerance, and love.

In fact, the world is getting smaller every day. The Internet breaks down barriers and communication and news take place on a global level. In a sense, we, humanity, write our own story. And with this acceleration of world events and communication, perhaps for the first time we can begin to understand how our minds interact and affect what we may have previously perceived as completely unrelated phenomena.

Even science proves that consciousness can affect what appear to be completely random and inanimate physical events. (See chapter on

of the Global Consciousness Project.) And Edgar Cayce made it very clear that there was a direct correlation between the natural disasters that might befall a given geographic location and the collective state of consciousness shared by those who lived there.

There are three main sources of information in this book:

1. ***Reading Edgar Cayce himself.*** Cayce provided quite a bit details of his own past lives as well as two of his future lives. Edgar Cayce gained credibility through his thousands of readings, many with highly verifiable diagnoses of his clients' physical conditions as well as predictions into future. I will draw on this data to see how well it stacks up with information from other sources.
2. ***David Wilcock's Ascension2000 website.*** The circumstances of his own life led him, often with great reluctance "to be dragged kicking and screaming", to the conclusion that he was the reincarnation of Edgar Cayce. He drew information from his own psychic readings, impossibly accurate astrological correspondences, dream memories of his life as Cayce, and more. And of course his striking physical resemblance to Cayce cannot be overlooked. We'll go over all of these pointers with a fine-tooth comb and see how they stack up against our other sources of information. As I stated in the previous chapter, David made a number of correct predictions based on his own dreams and readings.
3. ***Channeling "attuned trance telepathy" by Carla Rueckert a her co-workers.*** With the exception of Cayce readings, channeled data always seemed to rely on the faith of the reader rather than facts to prove legitimacy, and would create many premises that seemed highly implausible even to the open-minded. But I suspended my criticism when I read the Ra Material, formally known as The Law of One series, produced by the efforts of L/L Research (the team of Carla Rueckert and her associates Dr. Don Elkins and Jim McCarty) during the period 1981-1985. As I read these five books, I realized

I feel like I'm connecting with a source of wisdom that is deeper than anything I've ever been exposed to.

The Law of One series presented an all-encompassing cosmic perspective of where we came from, where we are going, and what the purpose of life is. And pieces of the puzzle were revealed that fit wonderfully into the stories of Cayce and Wilcock. So, to begin with, I would request you, the reader, to review the clues – pieces of the puzzle that I'm going to present to you - with an unbiased mindset and see if it all ties together and makes sense to you.

Our story actually begins sometime 100,000 years ago when we learn about Ra through the work of Carla Rueckert and L/L Research. If you can suspend your disbelief for a few moments, let's begin to unravel this mystery of mysteries that will ultimately lead us to the core of what life really is for answers.

Chapter 02: Ra, Ra the whole gang is here

In our waking consciousness, most of us are limited to inputting information into our minds from our five senses: sight, hearing, taste, touch, and smell. Many people base their lives on the principles of fun and escapism, constantly seeking greater and greater fulfillment of these five basic feelings. Religion teaches that there is something more, that life is eternal and the physical world is just an illusion from which we learn. They usually ask us to accept by faith that there is a God, that there are angels, and that we will experience an afterlife.

Occasionally, someone presents themselves as having the gift of piercing the veil, thereby actually being able to perceive events on the "other side" or demonstrate the ability to communicate with the consciousness that exists in that realm. Perhaps even ten years ago, the general public would have been very skeptical of this kind of ability. "Channeled" information must still be subjected to the same scrutiny as

any other information that comes to us, unless further investigation. We still have to use our sense of discernment to determine its validity.

I would tend to pay attention to this kind of information if it met the criteria of credibility outlined in the previous chapter, i.e. accurate predictions of the future, knowledge of previously hidden information, and perhaps most importantly, an intuitive connection to one's own inner wisdom. and spiritual heart.

John Edwards publicly demonstrates channeling to millions of people every day on his TV show Crossing Over. He certainly appears to have knowledge of hidden information as he tunes in with deceased relatives and friends of his audience participants, although controversy surrounds the issue. Edgar Cayce clearly meets the criteria of a trusted channeler. All major bookstores have shelves of books written by people who channel entities that exist in the higher realms of consciousness and impart bestselling wisdom to their earthly emissaries—entities like Seth, Ramtha, Sanaya, and DaBen.

Channeling is becoming much more mainstream, endorsed by such celebrities as Shirley MacLaine and many others. During the period between 1981 and 1984, Carla Rueckert provided some of the most amazing, profound, and intelligent information that has ever been presented, which has remained very obscure to the general public. However, this information happens to be highly relevant to our Edgar Cayce reincarnation story.

Rueckert held meditation groups every Sunday. She had been consciously and telepathically channeling information and connecting with various depersonalized entities for some time. One Sunday, January 14, 1981, something else happened; she lost consciousness and fell into a deep trance. Three others were present at the time, including her partner Don Elkins and their new assistant, Jim McCarty. It turns out that Jim will meditate and hold the light during the sessions and then transcribe them while Don puts

questions. The being identified itself as Ra with the following greeting:

"RA: I am Ra." Through this tool I am still he didn't speak. We had to wait until she was in the right mood, because we emit narrowband vibrations. Greetings in to the light and love of our Infinite Creator. We were called into your group because you need more advanced approach to what you call truth-seeking. We hope you we will offer a slightly different view of the information that is always a still the same."

For the next 4 years, the dialogue between Don Elkins and Ra's questions continued as directed by Carla. And this is where our Edgar Cayce reincarnation story really begins. Most of the information in this chapter is according to Ra, sometimes paraphrased in my own words with permission from Carly Rueckert, who reviewed it. I recommend that if this material resonates with you, you may want to read the original text with the channel as noted in the footnotes. If I have quoted directly from Ra, the quote is in capitals and bold.

For the first time in any recent history, in response to Don Elkins' questions, Ra explains in great detail the inner workings of our universe... the specific ways in which creation evolves from nothing to something and back to nothing. Ra describes the various phases or cycles of creation and how those who are on the higher evolutionary path must help those who are behind to maintain their own momentum and growth. Ra now exists in what is described as sixth density, **"the density where one perceives the sacramental nature of all things.**

As Ra evolves through seventh density, it prepares to reunite with the Creator, so **the dimension will, if our humble efforts are sufficient, we will become one with everything so we will have no memory no identity, no past or future, but existing in all."** Ra claims to radiate the energy of love over 90% of all Creation, and they work specifically with earthlings through dream interactions (hint: start thinking about

Edgar Cayce), inspirations and channelers. At the density where Ra exists, one lifetime is equivalent to hundreds of thousands of years, so Ra has been involved in Earth's history for a very long time.

According to Ra, there is an "octave" of eight major **densities** in the universe ***ethereal energy that most modern scientists would she considered eight "dimensions"***. The densities themselves are composed of living, intelligent energy and correspond to the planes of existence through which all of Creation must ultimately pass. Of course, "all Creation" includes you and me. Associated with each density is a certain degree or quality of consciousness that all entities must attain before they can move to the next density.

We on Earth are involved in the "third density" part of our evolution. The lesson or quality associated with third density is self-awareness, and the lesson of fourth density is the experience of love and the oneness of all life. Until we have the beginnings of a oneness experience (not of belief, but of experience), we must continually reincarnate, in a process called reincarnation, in the third density world.

We need some extra context at this point. In Ra's cosmology, the One Infinite Creator originally split into many parts that eventually became galaxies like our Milky Way. Ra always used the term "Logos" instead of "galaxy" when referring to any galactic body such as our own. The term "Logos" is very revealing because it was originally used in the Greek versions of the Bible and was later translated as "Word". That is why we now read in the book of Genesis: *"In the beginning*

was the Word. And that Word was God; and the Word was with God."

In Ra's cosmology, this seemingly paradoxical statement makes sense. Each Logos is a perfect part of the One Creator, but also has its own "personality" and identity as a conscious being. Each Logos then creates a basic outline for the "archetypes" of soul evolution that all its members will follow. These archetypes are experiences that every soul in the galaxy will have at some point in their evolution, all designed to lead them to a greater search for Oneness.

Ra refers to the many millions of stars in the galaxy as "**sub Logoi**", meaning they are also spiritually united with the Galaxy. The stars are conscious entities that are aware of the entire octave of densities and also have a degree of "personality" and free will as to how they carry out the Galactic soul evolutionary plan.

This allows them to "set the game" by designing planetary systems that must gradually evolve in octave densities. The Solar Logos sets the exact timelines for when each planet will progress through each density; and so, as the Cayce Readings once said, *"Each planet has its marching orders from*

of the Divine [i.e. Solar Logos]; only mankind has free will to defy the will of God [the solar Logos].

So the One Creator divides into galaxies, and the galaxies have some control over how life develops within them, such as the stars. The stars in turn have some control over how the planets evolve within their energy fields. Each planet also has a degree of free will as to how it will follow the instructions of its parent star and galaxy. This means that each planet has some say in how intelligent life like us will evolve. (Ra sometimes refers to us as "sub-sub-Logoi" in the same sense, indicating the unity of the energy fields of our souls with those of the planet, Sun, and Galaxy.)

Throughout our Galactic Logos and several of its close neighbors, the human corporeal form was chosen as the vehicle for conscious life to express itself on any given planet, therefore *"Logos (God) created men (man) in His own image.*

Both *the* Sun and the Earth had some control over the exact nature of human DNA and the bodies that now came into being as a result.

Wilcock's research, combined with Ra's original statements, shows us how the galactic Logos is able to program itself to create a certain type of life form. In my article with Wilcock entitled "The Scientific Blueprint for Ascension" he clarifies that the DNA molecule is actually "assembled" from the basic elements on a given planet by a spiral of intelligent energy that permeates the entire galaxy.

Russian scientists discovered and measured this spiral energy field in the laboratory, and it is often referred to as a "torsional (*ie. twisted, spiral*) radiation" with properties that make it very different from electromagnetic radiation. Torsion radiation has been shown to be highly responsive to consciousness, much more so than electromagnetic energy, and has very healing and spiritually enlightening effects when exposed to the organism.

In addition, Garaiev and Poponin's work showed that a DNA molecule will attract light (*photons*) to itself, causing the light to spiral through the molecule instead of following a typical straight path. Garayev's great discovery, now known as the "DNA Phantom Effect," is that ***once it is***

the DNA molecule itself removed from the chamber, the light will be to continue spiraling, all alone, held by some invisible force field.

This "invisible force field" is created by a spiraling torsion wave that originally gathered DNA around itself. More importantly, the research of Yu. V. Tszyan Kanchzen showed ***that***

the helical energy forming DNA can be transmitted from one organism to another.

In this experiment, a duck was bombarded with high-intensity torsional waves, which were then redirected into a separate chamber with the hen inside. In just five days, the hen would begin to look like a duck, including the growth of cobwebs between the normally bare toes.

So our DNA is just like a computer chip with different sections that can be turned 'on' or 'off'. The torsion wave pattern of the soul actually programs the DNA, much like the operating system and software tells the chips in your computer how to run. You can certainly buy two computers that are exactly the same, but by loading different operating systems and software, they will "look" very different on the screen and have very different functions once you turn them on.

As a human soul reincarnates from life to life, its "energetic signature" of torsion waves alters the DNA inherited from its parents to create similarities in facial appearance,

personality and physical characteristics such as the shape of hands and ears. other things.

The research efforts of Joseph Myers, PE (*prof engineer*) [www.reincarnation2002.com] and Dr. by Walter Semkiw [www.johnadams.net] has extensively confirmed these connections through the reincarnation demonstrations of many famous people in history. It also gives new meaning to the old adage about how married couples will become more like each other the longer they are together; as they continue to be exposed to each other over time, their soul vibrations intertwine at the DNA level.

To put this into perspective, Wilcock states that this spiraling "torsional" energy is actually more "real" than the DNA molecule itself, as it already exists in the fabric of space and time itself before any physical life appears on a given planet. Over time, the subtle, organized, spiraling pressures of "torsion waves" on physical matter naturally assemble the available elements on a given planet into the basic building blocks for life, such as amino acids, which eventually form into "deoxy-ribonucleic acid" or DNA.

It is interesting that one of the original scientists who discovered the DNA molecule, Prof. Crick, proved that the DNA molecule is far, far too complex to have evolved by chance, and this Wilcock/Ra model gives us a solid explanation.

Another key is that the galaxy will have different zones of energy density that will split it up like a pie when viewed from the north or south galactic pole. Then, as the star travels through the galaxy, it will pass through different densities at very precise time intervals. This "density shift," as Ra calls it, also creates more intelligent and complex torsion waves, which in turn transform the DNA structures on each planet. This causes the higher forms to quickly replace the older life forms.

Ample evidence of this can be seen in our fossil record because evolution is not considered a gradual process but

rather, it occurs in sudden shocks known among scientists as "punctuated equilibrium." Likewise, as human beings we have never yet found the "missing link" that could support the Darwinian model of gradual evolution; for some reason unknown to mainstream science, about 75-100,000 years ago, the human organism experienced a massive increase in brain size and the elegance and utility of its body. According to Ra, this was caused by the spontaneous evolution of DNA, caused by our Sun's transition to a higher energy region of the galaxy.

So, when this energetic "upgrade" occurred in our own history, the third density life cycle began on Earth. One of the basic cosmic laws is that third density experiences for any given planet occur in "**major cycles**", each lasting approximately 25,000 years. This period of 25,000 years corresponds to how long it takes a star to pass through a given energy band as it orbits the Galactic Center, and Wilcock's scientific research has provided extensive evidence to support this concept.

At the end of each major cycle, the highest possible level of vibration for third density is reached, and at this point entities can move into higher densities through a process Ra refers to as "harvesting" if they are ready. The normal period given to an entity to transition from third density is up to three "major cycles" of 25,000 years. After three "Great Cycles", the planet will automatically move into fourth density through the simple physics of vibration, whether its inhabitants are ready or not. A third density body would not be able to live on the planet because its DNA would no longer be supported by the torsional waves in the area. Higher density life forms exist on most other planets in the Solar System, although these planetary conditions are quite inhospitable to human beings.

Of course, any great cycle of experience for a given entity, such as a human being, will involve many separate lifetimes, i.e., physical incarnations. If a third density planet has reached the end of the cycle and is about to move into fourth density, then you

residents who are not ready to progress will end up reincarnated on another third density planet.

This does not happen by "accident" or simple conscious intent, but rather involves the intelligently directed transfer of the souls themselves and the appropriate genetic material to create physical bodies to match the souls. This "planet-hopping" process is controlled by groups of interplanetary cosmic beings like Ra, and since star systems are constantly moving into different energy zones throughout the Galaxy, something always needs to be done. From Earth's point of reference, these beings are referred to as angels, celestial beings, extraterrestrials, or perhaps lords of karma.

A group of these beings who call themselves the "Confederation of Planets in the Service of the One Infinite Creator" control much of our Galaxy that we now inhabit and are collectively responsible for directing the movement and evolution of souls from planet to planet. .

Typically, those who evolved together on a certain planet are kept together when they move to a new planet; so if a certain percentage of entities in third density did not pass after three great cycles, then they would be moved to another planet as a group. However, the members of this Confederation saw that there were several groups of third density "cycle repeaters" whose numbers were too small to justify terra-forming an entire planet just for them.

Therefore, Earth was chosen as a unique experiment in which "cycle repeaters" from many different planetary populations would come together under one roof. It is very unusual for a planet to have as much racial diversity as we do on Earth; for example, it is within the Caucasian races that there are great differences in appearance that can be observed between Slavic, Mediterranean and Western European peoples. The same would be true in the Asiatic races among the Chinese, Filipinos, and Japanese, as three of the clearest examples.

The reason for all this genetic diversity is that these souls came here from different planets; The Chinese, for example, are said to come from a planetary system surrounding the star Deneb. So their souls came from stars and planets that had slightly different "personalities" in terms of how the DNA was structured to create the appearance of a human being. These fundamental differences cannot and should not be erased because, according to Cayce, they are all aspects of the inner character and harmony of the soul.

Ra explains that this great "experiment" failed in the sense that not a single entity passed after our first great cycle ended some 50,000 years ago. Normally, it is expected that 10 to 20 percent of people would make it after the first cycle. At the end of our second great cycle some 25,000 years ago, only 120 entities were ready to graduate and chose to stay behind and help others. Normally more than 60 percent of people graduate after the second major cycle on a third density planet, so the small remaining percentage of people learn the importance of love before the end of the third and final cycle.

At the end of the second great cycle on Earth, it became alarmingly clear that the "experiment" of combining all the cycle repeaters together was not working - great spiritual suffering was occurring and a dramatic form of help was needed to turn things around. As a result, vast numbers of fourth, fifth, and especially sixth density entities, including those from the Ra group itself, volunteered to take human incarnations to try to help. Ra refers to these souls as "wanderers" and if you feel like you remember all of these statements as if you knew them before, you may be one of the nearly 100 million "alien souls" now walking the face of the earth.

The process of finally recognizing yourself as a Wanderer is not very easy or acceptable to most others, but it can answer many uncomfortable questions about why life on Earth seems so terribly disharmonious and unbalanced. Contrary to popular belief, Wanderers are not necessarily expected to "do" anything or "save the world" with their

by one's own efforts; by simply remaining in the physical body and maintaining a joyful state of mind as much as possible, they have a tremendously beneficial energetic effect on the mass consciousness of humanity. This, in turn, can dramatically increase the number of souls who will be eligible for graduation.

Earth is actually the fourth planet in our solar system to host third density life forms. At some point, millions of years ago, Venus was the first planet to be inhabited by life forms similar to human beings on Earth. The inhabitants were transitioning from third to fourth density and were being assisted by a higher group. During our own 3rd density experiences we **were assisted by 6th entities.**

density. Because we were extremely less warlike than humans, we found this teaching useful. We have not developed the interrelationships of your monetary system and power.

We were a more philosophical 3rd density planet than yours

own..." About 17 percent of third-density Venusians graduated or "ascended" and continued to evolve through fourth, fifth, and sixth densities. Ascension is another name for the process beings go through when they change densities. As the Venusians ascended through the densities and approached the experience of original creation, they also began to lose their separateness. This group of ascended Venusians now exists in sixth density as Ra, who describes himself as **"a social memory complex, a great**

a group of fully integrated souls—or "group" for short soul".

The second planet that hosted third density humans was known as "Maldek" which in turn exploded in a crazy global nuclear disaster caused by war. Normally such events are not allowed because they violate the free will of many innocent beings throughout the planetary system, but even the "Guardians" are not perfect.

In this case, the nuclear conflagration occurred very spontaneously and unexpectedly, and the explosion of the planet in turn created debris that formed comets and the Asteroid Belt. [Wilcock's data assures us that extraordinary measures are now being taken to ensure that this no longer

will not repeat, which is why many UFO whistleblowers come forward with reports of UFOs powering nuclear missiles.]

The people of Maldek have entered into a **“social memory complex or tangle of fear”**, which took more than 200 thousand years before it could be broken. As a group, they then decided to take a series of incarnations in bodies with drastic physical limitations that would create "karmic mitigation" by preventing them from being able to create any advanced civilization capable of self-destruction. They were the first entities to populate the Earth and we have fossil records of their "clunky" bodies as Neanderthals.

The third and last planet to host third-density humanoids before Earth was Mars, on which ample evidence of an advanced civilization still rests, including pyramids and monuments with precise geometric relationships to each other and to the planet itself, as seen in the *Enterprise Mission* work of Richard C .

Hoagland among others.

The Martians were doing quite well until they too experienced a global catastrophe; in this case, they didn't destroy the planet itself, but rather blew away its atmosphere, creating the arid, desolate wasteland we see now. The souls and genetic material of the Martians were moved forward some 125,000 years in time to be placed on Earth at the beginning of her first third density cycle about 75,000 years ago. Until then, only second-density life existed on Earth. **"The second density is the density of the higher**

plant and animal life that exists without ascension

to infinity." At this time, Ra existed in sixth density, the level of

"compassionate wisdom," and began her service to Earth as she assisted in the genetic "packaging" and transmigration of the Martians.

“Don Elkins: I assume you're saying the guards transferred here the Martian race after the race had died in the physical sense to Mars."

RA: That's true."

In addition to helping with the Martian migration, there have been several other circumstances where Ra has intervened in Earth's history:

RA: The first attempt to help your peoples happened about a year ago 75,000 years. [He helped the Martians come to Earth]. She was next

aid given to those of Mu about 58,000 years ago. She was next offered help to Atlantis about 18,000 years ago. Another one the attempt was to help the Egyptians [and some in the South America] about 11,000 years ago. About 3,500 years later [B.C 7500 years] was again offered to some in South America Help. About 2300 years ago there were several attempts to help to the people of Egypt by other members of the Confederacy. Remaining part of this cycle we never left your 5th dimension.

The Ra intervention most important to our story (remember this book is called "The Reincarnation of Edgar Cayce") is the involvement of the Egyptians 10,500 years ago. There is quite a bit of specific information about this that I quote verbatim from the reading of Ra below, starting with where Ra describes the actual manifestation of the body in Egypt:

I am part of a social memory complex that has traveled out from a planet in your solar system, the one you call Venus. We are an old race by your standards. When we were in the 6th dimension our physical beings were what you call golden. We were tall and rather delicate. The covering of our physical body complex had a golden sheen. In this form we have chosen to come among your peoples. Your people were not much like us in physical appearance. So we didn't mix well with the population and we were obviously different from them. Our visit was relatively short. That was when we built the pyramids. **When we chose this mission among your nations,**

we would be perceived as light if we came to earth in its natural form.

"Now we feel a great responsibility to help with the removal certain distortions that were given to the Law of Unity. We, like social memory complex or group soul, we followed up contact with a race on your planet you call Egyptians. We spoke to one who heard and understood (we later find out that it was Ra-Ta, the high priest and previous incarnation of Cayce), and was in a position to lay down the law One. However, the priests and nations of that time quickly twisted ours message and robbed them of the compassion that unites them . (AND

therefore, Ra feels a responsibility to heal the way their message was misrepresented and delivered.)

During this period of activity in Egypt, Ra built the pyramids as a healing chamber by levitating stone:

RA: The greater pyramids were built by our ability to use forces

One. RA: Imagine activity in all that is

created. Energy, although finite, is quite large. This energy is intelligent. It's hierarchical. Just like you have hierarchy of vehicles or bodies, so every atom has one material such as stone.

STONES ARE ALIVE. THIS IS YOUR CULTURE

SHE DIDN'T UNDERSTAND. One can speak with better attuned higher bodies, whether rock or human. After making this connection a request may be made. Infinity Rock Intelligence communicates with his physical vehicle or body and then he performs the required division and movement.

Don Elkins: Did one individual mentally do it?

RA: There is a difference between individual power through the Law of One and the power available through the group soul's combined understanding of the Law of One. One individual, cleansed of all defects, could indeed move a mountain. However, in the case of a mass understanding of unity, each individual may contain an acceptable amount of distortion and yet the mass mind could move mountains. Among your people at this time there are people whose purity is already in harmony with the intelligent infinity.

Don Elkins: Why not create it as a whole instead of blocks?

We didn't want to be worshiped as builders of a miracle pyramid. So it seems to be created, not thought.

RESURRECTION BY INITIATION IN THE QUEEN'S CHAMBER

RA: The concept of initiation requires the focus of the being on the quest Creator. Initiation in the Queen's Chamber [Great Pyramids] involved surrendering to such a desire to know the Creator v to the full extent that the cleaned incoming light is balanced way pulled by all energy centers or

chakras meeting in the inner eye chakra. and opening the gateway to intelligent infinity. Then the real is experienced life, or as your people call it, resurrection .

I'll jump here to an excerpt from Cayce's reading about the creation of the pyramids:

“The great pyramid was built as an initiation hall, an “initiate of the house” for those who had dedicated themselves to special services in the mysteries of the mystery religion of Egypt. It was built by the application of those universal laws and forces of nature which cause iron to float in the air. So the pyramid was built by levitation, supported by songs and chants.’

Later I will go into much more detail taken from Cayce's reading of Ra-Ta, an Egyptian priest who was a previous incarnation of Cayce. However, this is an amazing parallel that connects Ra and Cayce, regarding the creation of the pyramids by levitation of stone. More parallels will appear in the next chapter as we go deeper into Ra-Ta's life, and later we will see how well Wilcock fulfills Cayce's prediction of Ra-Ta's return in 1998.

Some readers will immediately say, “So what? All it proves is that Ruekert studied the Cayce material. Remarkably, Carla was completely unconscious during the Ra session and remembered nothing that happened when she returned, which had never happened in any of her previous 20 years of channeling experience.

If you met her yourself, you would see that she is clearly not a person who is inclined to lie about anything. I spoke with Carla Rueckert and asked her about her own awareness of Edgar Cayce to see if there was any possibility that she gained this information through prior knowledge of the Cayce Readings.

She did not know that the Cayce Readings said anything about the time period of the creation of the pyramids and the levitation of rocks, or how exactly Cayce's data corresponded to Ra's data, at the time I asked her the question. . Her contact with Cayce was mostly related to his alternates

remedies and we must remember that there are over 300 books that have been written on various points of the Cayce reading. Carla became deeply involved in channeling and researching her own material when she was still very young.

It is also important to mention here that Wilcock's research has shown that the Law of One / Ra series has as much scientific credibility as the Cayce Readings, far beyond the reach of one person to create with only their imagination.

A large part of Wilcock's mission in this life was to continually provide more and more scientific evidence to support the statements made in the Law of One / Ra series. In most cases, there was simply no proof at the time that the original series ran from 1981-1985, and it is highly unlikely that Carla Rueckert could have fooled the inquisitive mind of a PhD student. theoretical physicist in promoting such a far-reaching, internally consistent and specific cosmology.

In addition, Wilcock's research revealed answers to many unsolved physics questions that puzzled the original L/L Research team, such as the meaning of the term "spiral line of light." Ra would often correctly use words that no one at L/L Research had ever heard of, which would require an unabridged dictionary to verify. Additionally, in the fifth book of the Law of One series, Ra also demonstrated the ability to perform "medical readings" very similar to Cayce, using technical medical terms to accurately diagnose Carla's condition and provide treatment suggestions.

Summary of important points:

1. Ra is the group soul or social memory complex. Ra had a third density existence as the population of the ascended planet Venus.

2. Ra now exists in sixth density, almost in unity with the Creator. Ra serves earth people in their evolution to higher

density, just as the higher density helps the population of Venus in its upward course of evolution.

3. Most of Ra's involvement was through psychic and dream interaction with Earthlings, although in 10,500 BC Ra manifested a body in Egypt to assist a priest who had an affinity with the "law of one" (which Cayce was in a previous incarnation). Ra also built the pyramids during this period by levitating rock. Cayce also said that the pyramids were built by levitation 10,500 BC

4. Ra's involvement in Egypt and the creation of the pyramids did not go as planned. Others misused what Ra created and used it for their own purposes. As a result of creating distortions in Earth's evolutionary path, Ra had to (or chose to) stay with us and make reparations.

Ra in Egypt manifested a body different from the human body, tall, delicate and with a golden luster.

Chapter 03: The Story of Ra-Ta

The story of the reincarnation of Edgar Cayce is indeed connected with the solution of the mystery. Ra leaves a trail of time-stamped footprints throughout our history, and uncovering those footprints is one of the things that helps solve this mystery and lend credence to the story. So for another clue we need to understand the history of Ra-Ta as revealed in the spiritual framework of an Edgar Cayce reading.

I will also be drawing on a past life hypnotic regression performed by renowned author and researcher Jess Stearn, a person Cayce Readings said lived in the Ra-Ta period. This information was given in Stearn's 1993 book called "Intimates Forever". (Jess Stearn also wrote perhaps the most popular book about Cayce, called The Sleeping Prophet.)

Before discussing Ra-Ta, it will be important for some readers to be sure that Cayce's reading did not place the Ra group or his own previous incarnation as Ra-Ta at the "top of the pyramid" in a spiritual sense. In the last chapter we saw how Ra used the word "Logos" to describe the personality of our Galaxy as a conscious being. It is stated in the Cayce Readings that the Logos chose to accept personal Earth incarnations from the very beginning of our third density cycle of experience. [This could have been due to the huge problems already experienced with Mars and Maldek.]

The original incarnation of the Logos was known as "Amilius", who became the prototype of "Adam" in the book of Genesis. After many very historic spiritual incarnations, including Melchizedek, Elijah, and Moses, the last incarnation of the Logos came on earth in the life of Jesus, who called himself "the last Adam." As soon as Jesus had completed his personal consecration, he began to say "*I am Logos*", which is now translated again as "*I am the Word*". The Cayce readings also say that Jesus was the first person to complete this process of self-transformation, and that others would follow a similar path at the end of the cycle.

Thus, it is well known to Cayce scholars that the Logos is central to the management of human civilization on Earth; but one entity certainly cannot be expected to handle all the responsibility alone without first differentiating into many different beings at different levels of density. The process of guarding, spiritual support and moving souls from one planet to another requires a large number of personnel, with contacts both in the higher realms and on the planets themselves.

Thus, in a little-known prayer discovered by Wilcock's associate, the Cayce Readings refer to the names "Ra" and "Ra Ta" separately, suggesting that they are two different entities, both of which are responsible for such administrative tasks. This point is often overlooked by most ARE members, yet it is perhaps the most direct clue in all of the Cayce Readings that his source was well aware of the Ra group.

According to the Cayce reading, Ra Ta was an early incarnation of Cayce in Egypt in 10,500 BC, and the context from the Rueckert/LL Research work clearly shows that Ra was providing direct assistance to Ra-Ta at that time. The following story, derived from the Cayce Readings, is largely summarized from WH Church's book entitled "Many Happy Returns, Past Lives of Edgar Cayce" and Mark Lehner's book entitled "Egyptian Heritage". All the essential points of the story can be reconstructed between these two books.

Ra-Ta began his life by being born in a less civilized area, ruled by the "Zu" tribe (perhaps the ancient Sumerians) somewhere between the Caspian Sea and the Caucasus Mountains. The Cayce Readings tell us that Ra-Ta was a very unusual child in that he had pale white skin and blue eyes in an area where others did not appear this way. His mother explained that the "gods (meaning aliens) of the area" spawned her pregnancy, thus making Ra-Ta an alien-human hybrid. Although she was the daughter of the leader of the Zu / Sumer tribe, the tribal elders were greatly frightened by Ra Ta's bizarre birth and appearance, as well as the problem that she did not have a husband, which was frowned upon. in their culture.

Therefore, the elders ordered that she and Ra-Ta be driven out of the country with a group of helpers to protect them. Over time, they reached the slopes of today's Mount Ararat in Turkey. During this time period, the Atlantean civilization was just beginning to spread to other areas from the central land of "Poseidia" in the area of present-day Cuba and Florida. The Turkish region that Ra-Ta and his mother came to had only recently begun to have diplomatic relations with the Atlanteans, and so was still behind in a technological sense.

As Ra-Ta grew up, it became clear that he had prophetic powers and could transmit very accurate psychic information. At the age of 21, he had a prophetic dream that a global cataclysm would occur in the not-too-distant future. Most of the island continent of "Poseidia" was to be flooded, and his own area would also suffer a cataclysm. His intuition and scientific research of the Global Grid of "Energy Lines" came together to

indicated that Egypt would be the safest place to go to weather these earth changes because it was in the center of the grid. (This has now been scientifically verified by Becker-Hagens lattice studies, as reported in Wilcock's *Convergence* series.)

When the earth's poles shift, Egypt will be the balance point of their movement. Ra-Ta communicated this prophecy to the king's son, Arart, and a pioneer group of 900 led by Arart, with Ra Ta as their spiritual leader, made the journey from Turkey to Egypt.

After a long and arduous journey, they arrived in the Egyptian city of Luz. At first there was mistrust and scrutiny, but eventually the Egyptians accepted the Atlanteans and promoted them. Arart was proclaimed king and Ra-Ta was accepted as their high priest. Over time, spiritual and moral reforms were introduced to Ra-Ta and he became beloved by the people. He built temples for self-healing and transformation and was able to perform many miraculous deeds.

By this time, many other Atlanteans were already receiving visions of the coming flood and were emigrating in droves away from the island continent of Poseidia in the Atlantic. As part of a "really very busy life" [294-148], Ra-Ta began using an Atlantean anti-gravity vessel to travel abroad and interact with Atlanteans and other cultures for 10 years. During these travels, he learned much more about Atlantean science and technology, which included many very advanced concepts about how science and spirit fit together.

In addition, the Atlanteans wished to create a repository of their accumulated knowledge and wisdom so that it would not perish, and also understood that Egypt would be one of the three safest places to store a copy of their records. Similar records were prepared in Posiedia itself at the Ilta Temple and at another site in the Yucatan region of Mesoamerica. Since Ra-Ta was the ambassador and spiritual leader of Egypt, negotiations were held with the Atlanteans on how to go about the process of preservation and record keeping.

Earlier in his spiritual ministry in Egypt, Ra Ta established a moral code that included fidelity in marriage and cohabitation. Before Ra Ta, it was customary for men and women to be separated and meet only in a special conjugal chamber for intimate encounters. After a third ten-year period traveling abroad, he returned to Egypt and was horrified by what he found: in the relatively short time he had been gone, its sacred temples had been turned into sex playgrounds.

Much confusion ensued as he rushed to condemn these actions, and some individuals became very angry with him and began to devise a way to get him removed from power. As they watched him, they realized that he was extremely fond of a young woman who danced in the temples named Isris. They were then able to cleverly trick Isris into seducing Ra-Ta.

Once Ra-Ta took the bait, the illicit affair was exposed, and the conspirators then pointed accusing fingers at how he had violated his own spiritual principles of monogamous marriage. To make matters worse, Isris was the favorite of Arart's son "Araaraart", who became the new king. Jealousy and the desire for revenge can certainly go a long way, and in this case it led to the banishment of Ra-Ta and the 231 followers who chose to go with him. They ended up in what is now called

Ethiopia and what was then called Nubia. Ra Ta reflected regretfully on the monumental consequences of his courtship.

But wherever Ra Ta lived, he carried his blessings with him, and the banishment only helped the further development of his soul:

“With the entry into the Nubian land there was such a change that in every term that can be applied to human experience there were better conditions... As the priest in this creative period entered more and more into closer relations with the Creative Powers. . Greater was the capacity of the entity or body of Ra Ta to be able to create or bring about the material manifestations of this relationship...hence the peace enjoyed by all throughout the land...”

During his exile, Ra-Ta met an earlier human incarnation of the Logos known as Hermes, who was later honorably called "Thothermes Trismestigus", meaning "Thrice Great Hermes". The Egyptians praised him as "the scribe of the gods" or "the lord of the divine words". According to Church, Herm's life is "shrouded in mystery". He apparently appeared "out of nowhere". He had prophetic dreams and could see "forwards and backwards" in time, but he was low profile and modest.

Hermes and Ra Ta were closely linked, and Cayce referred to Hermes as "the heart and tongue of Ra". Here we must remember that the name Ra Ta was eventually shortened to just "Ra". So this quote seems to mean that Hermes had the same influence on Ra-Ta as the sixth density Ra group.

The historical figure of Hermes is still strongly revered by the secret societies of today's world, as you can see when you enter the National Museum of Art in Washington, DC, where you soon enter a giant three-story marble room surrounded by magnificent black columns and a huge statue of Hermes in the middle. Most people don't think much of this connection because Hermes was the patron of the arts in Greek mythology. Cayce was a Freemason himself, so it must have come as a great surprise to his Masonic cohorts that his readings suggested that Hermes was actually an earlier incarnation of Jesus!

Meanwhile, things were falling apart in Egypt for King Araaraat. There was discontent and rebellion among the people without the calming vibe of Ra Ta, even though he was often out of town. Law and order was crumbling, and the Atlanteans' hopes and dreams for the future of Egypt were crumbling.

The king regretted his banishment of Ra Ta. After nine years, the king finally rescinded the banishment decree and Ra Ta was allowed to return. In reality, this resulted in the king ending up as a mere puppet while Ra Ta was promoted, but the king willingly allowed this to allow the divine purpose inspired by Ra Ta to be reestablished.

So peace and harmony once again reigned in Egypt. Ra-Ta lived an unusually long life, which the Cayce Readings attribute to him spending a lot of time in the pyramid to take advantage of the rejuvenating energies that the pyramid produces. Church posits that Hermes also helped Ra reverse his aging trend.

It was during this period of return from exile that the pyramids were built. Cayce gave credit to Hermes as the architect, while Ra Ta, now known as Ra, was the second most important collaborator. By some esoteric means the stones were levitated and set into place.

Jess Stearn, author of *The Sleeping Prophet*, published a book in 1993 called *Edgar Cayce's Mysteries of Reincarnation*

Chapter 04: The Egyptian Pyramids

Before going into Wilcock's fulfillment of Cayce's prophecies, I felt it was important to insert this chapter on the historical background of the Great Pyramid and Egyptian mythology and then evaluate how it ties in with the information from Cayce and Rueckert, as the information presented is somewhat at odds with the traditional historical perspective of this period. For reference, according to the combined information from Rueckert and Cayce's channeling, Ra and Hermes built the "Levitation Stone" pyramids 10,500 years ago.

Historically, the Great Pyramid is believed to have been built around 3000 BC by the Egyptian pharaoh Khufu. The Association for Research and Enlightenment, or ARE, (a foundation set up to preserve the Cayce data set) actually ran a carbon-14 test on the pyramid to determine its age in an attempt to reconcile this discrepancy between the age as stated in Cayce and the age according to conventional history . The result of this test seemed to confirm the historical age, but how do I do it further

researched, I found an interesting article published on 21 June 2001 on the BBC website which I quote below:

“After a breakthrough in archaeological dating techniques would a complete rewriting of the history of modern humans may have been required. British and American scientists found that radiocarbon dating, which is used to provide a rough guide to age object, can be wrong by thousands of years. It means that humans could have been on Earth much longer than they have formerly thought, and accepted versions of early history might require radical rethinking. Experts have known for years that carbon dating is imprecise, but until researchers from Bristol and Harvard completed their study, no one knew to what extent.

So the carbon-14 test on the pyramid is in no way conclusive, and the historical date of the pyramid's creation cannot be verified from such a study.

In the third century BC, Plato wrote of being told that the Atlanteans invaded Egypt nine thousand years ago, or 11,000 years from today, which would be quite close to the 10,500 year date determined by Cayce. This also fits with Cayce's story of the exodus of Ra-Ta and his group from Atlantis and the occupation of Egypt. This is the only direct reference in known recorded history to the existence of Atlantis.

Also, according to Robert Sheer's article, water marks were found on the sides of the Great Pyramid at a level 400 feet higher than the Nile River today, and deposits of sea salt inside the pyramid support the theory that it and the Sphinx must have been built before the melting time of the last great ice age. about 12,000 years ago.

According to Zecharia Sitchin in his book *Stairway to Heaven*, the common view that the Pyramids of Giza were actually the tombs of the pharaohs cannot be supported. No body of a pharaoh has ever been found in the Great Pyramid. Sitchin noted the fact that there are no hieroglyphs on the inner walls of the pyramids. He assumed that this was because they were built before the written language of the Egyptians. Conventional archaeologists date the Great Pyramid

according to a series of painted red "break marks" that were found in the corridors above the King's Chamber.

Yet all of these "break marks" were written at the only suitable angle for the arm of a person to break into these very narrow "relief chambers" in the same manner as Colonel Howard Vyse had just done at the time they were found. Convincing evidence suggests that Vyse deliberately falsified the quarry marks and attributed the construction of the pyramid to Pharaoh Khufu, because the morale of the workers was very low, his finances were almost completely exhausted, and no significant archaeological discoveries had yet been made.

In addition, there were several errors in the way the quarry marks were written that were consistent with errors in Budge's seminal work of the time to decode Egyptian hieroglyphics. Vyse had a copy of Budge's book, so all the evidence suggests that it was a deliberate forgery, as Vyse produced a report that combined hieroglyphs from different periods of Egyptian history that were separated by hundreds of years.

Sitchin believes that the pyramids were healing chambers and according to the Rucert Ra material he also states that the Great Pyramid was a healing chamber that served to concentrate etheric energy. At one point Napoleon was said to have spent a night in the Great Pyramid. He was said to be "pale and dazed" when he emerged and, when asked about his experience, replied: *"You wouldn't believe me if I told you."*

The actual construction of the pyramids has historically been a bone of contention and controversy even among conventional Egyptologists. The technology to put sixty-ton blocks of concrete together with the precision found in the pyramids simply does not exist today. On March 2, 1999, Fox News presented a television program investigating the mysteries of the pyramid, where Fadel Gad, an Egyptologist, hypothesized:

"Did the Egyptians think about UFOs at that time? Yes! A highly sophisticated, highly intelligent species that captured this planet earth and caused the evolution and exploration of human consciousness.

And David Pratt stated the following in an article about the pyramids:

“The pyramid is an unparalleled feat of engineering and craftsmanship. It is more precisely aligned with the four cardinal points than any existing structure, including the Meridian Building at the Greenwich Observatory in London. The 350-foot-long descending passage is so straight that it deviates from the centerline by less than a quarter of an inch from side to side and only one-tenth of an inch up and down—comparable to the best laser guided drilling. done today

The casing stones, some of which weighed over 16 tons, are so perfectly shaped and squared that the mortar-filled joint between them is only one-fiftieth of an inch—the thickness of a human fingernail. The Egyptologist Sir Flinders Petrie described such phenomenal accuracy as "the work of the finest optician"; work of this caliber *exceeds the capabilities of* modern technology. The face stones show no tool marks and the corners are not even slightly chipped.

The granite chest in the King's Chamber is carved from a solid block of hard red granite—so precisely that its outer volume is exactly twice its inner volume. Engineer and master craftsman Christopher Dunn rejects the theory that it could have been cut and hollowed out with diamond-tipped bronze saws, because when pressure was applied, the diamonds would have worked their way into the much softer copper, leaving the granite virtually invulnerable. .

In his view, the evidence shows that the Egyptians would have possessed ultra-modern tools, including pipe drills that could cut granite 500 times faster than modern drills. But that is not all. The Great Pyramid embodies advanced knowledge of geometry, geodesy (the science of measuring the earth) and astronomy.

Another point of interest is that the pyramids that were built for the kings of the 5th dynasty - *said to be* only a few decades after those at Giza - were significantly inferior in size, materials and workmanship. One would have to wonder why, if the Egyptians really had the ability to build with the precision demonstrated at Giza, there was such a surprising loss of construction skills in the later pyramids.

And then we have to consider the number of geometric proportions associated with the Great Pyramid that indicate a precision of workmanship and a knowledge of the Earth and the Solar System beyond any information the Egyptians would have had. For example:

The base of the Great Pyramid x 43200 equals the equatorial circumference
Countries with better than 1% accuracy

Height x 43200 equals the polar radius to within 0.2%

(Note: Whoever built the pyramids knew that the earth was not a perfect sphere because there were different measurements for the equatorial and polar circumferences)

4320 is the number of years it takes the earth to move through 2 signs of the zodiac, or one sixth of the precession of the equinoxes

The three main pyramids at Giza mimic the stars of Orion's belt in size and arrangement as they would have appeared in 10,450 BC.

If the Nile is represented by the Milky Way, then the position of the three pyramids in relation to the Nile exactly reflects the position of Orion's Belt relative to the Milky Way at the time of the solstice in 10,500 BC

Each of the pyramid's four walls, measured as a straight line, is 9,131 inches long, for a total of 36,524 inches. The exact length of a solar year is 365.24 days

The circumference/height ratio of the Great Pyramid is exactly 2 pi. The constant pi in mathematics was not discovered until much later

The pyramid is located in the exact center of the earth's landmass. Its east-west axis lies exactly on the Earth's longest parallel - passes through Africa, Asia and America. The longest terrestrial meridian, through Asia, Africa, Europe and Antarctica, also passes directly through the pyramid

The sides of the pyramid are very slightly and evenly curved or concave. This effect was discovered around 1940 by a pilot taking pictures

aerial photos. Today's laser instruments show that all these perfectly cut and purposely bent blocks exactly copy the curvature of the Earth.

I quoted from Zechary Sitchin's book *"The Stairway to Heaven"* earlier in this chapter. In this book, Sitchin very expertly evaluates a large amount of evidence relating to the biblical and early Egyptian periods, and based on this evidence, he concludes that the Egyptian gods were not mythical beings, but in fact extraterrestrials with extraordinary powers. The bottom line is that there are many reasons why the normal historical view of the building of the pyramids makes less sense than the story presented by Ra in Rueckert's channelings.

The Cayce Readings suggested that Ra and his consort Isis were later mythologized into gods by future generations of Egyptians. In a cursory study of Egyptian history for this chapter, I found that the sun god Ra was described by Michael C.

Carlos from the *Museum of Emory University* as follows:

"All Ra had to do was think of a thing and there was... Of course the people needed a leader so Ra took human form and ruled Egypt under the name of Pharaoh." His the reign was long and prosperous and lasted for thousands of years."

And other historical references to Ra:

"Then Ra assumed the form of a man and became the first by a pharaoh who ruled over the whole earth for thousands and thousands of years and he gave such crops that the Egyptians forever spoke of the good ones things that happened in the time of Ra.

However, the time was approaching when he must leave the earth to rule forever in of the heavens and let the younger gods rule in his stead. Because dwelt in the form of a man, an Egyptian pharaoh, Ra was losing his wisdom; yet he continued to rule, and no one could take his power from him."

"...He has shone upon the Earth since time immemorial [in the form of] Diskus, the prince of light and glow. Gives light and shine. He gives light to all nations. It sails

is above the sky and never rests and tomorrow his vigor is like previously; growing old [today], will become young again tomorrow. He controls the bounds of eternity, circumambulating the sky and entering the Tuat to enlighten the two lands he created. He was a sun god, they said

commanding the chariot that drove across the sky during the day. The king, was the patron of the pharaoh. Ra is the most important god of the Egyptian pantheon...

"...Ra's position in the pantheon is unusual." He is the only god besides Oširis which is said to be definitely not on country. Ra, they say, is an aging god, still powerful, but too old to care for his children any longer, so he's retired to heaven solely to watch over the world..." *"The movie apparently suggests that's pretty much it, what happened in ancient Egypt: that Ra and the other gods were extraterrestrials who made a deep impression on the predynastic Egyptians, who then recalled a catalog of religious rituals based on these early experiences. These rituals eventually became solemn and sacred ceremonies performed by priests and pharaohs for thousands of years afterward. According to at least one researcher, this scenario is incredibly close to the truth!"* And in closing, we repeat the words of Ra as relayed by Rueckert:

We have chosen to come among your peoples. Your people were not much like us in physical appearance. So we didn't mix well with the population and we were obviously different from them. Our visit was relatively short. That was when we built the pyramids. When we chose this mission among your peoples, we would be seen as light if we came to earth in our natural form.

"We now feel a great responsibility to help remove certain distortions that have been given to the Law of Oneness. We, as a social memory complex or group soul, have made contact with a race on your planet that you call the Egyptians. We spoke to one who heard and understood (Ra Ta) and was in a position to enact the law of One. However, the priests and nations of that time quickly twisted our message and robbed it of the compassion that binds together unity.

And in the next chapter we learn how Ra still communicates with humanity through the form of who was once Ra-Ta reincarnated as none other than David Wilcock...

Chapter 05: The Prophecy Fulfilled

"Is it not fitting then that these (referring to Ra Ta and his followers) must return? How can this priest evolve to be in this position, to be in this capacity of liberator of the world in its relations with individuals in the following periods, because in this period, or in 1998, he must re-enter." (from the Cayce reading)

So let's finally move from Egypt to the 20th century . David Wilcock was born on March 8, 1973 in Schenectady, New York. He grew up in a somewhat liberal family with an openness to psychic phenomena from the time he was a small boy, compared to Cayce who had a rather narrow fundamentalist Christian upbringing.

Wilcock's childhood was filled with a variety of paranormal phenomena, and he began reading full-length paperbacks on ESP and hypnosis when he was just seven years old (see Figure 5.1) and performing psychic mind-reading demonstrations on his classmates.

Curiously, Wilcock was inspired to place a 1981 American Lung Association Christmas Fund sticker on Harold Sherman's book "How to Make ESP Work For You" (Figure 5.1), documenting that he read the book at age 8 (figure 5.2). . Both his choice of reading material, i.e. ESP and hypnosis, and the fact that he paid special, time-stamped attention to a chapter of an ESP book related to healing powers, seem to be evidence of subconscious past life memories as Edgar Cayce seeped into the foreground.

In high school, Wilcock accurately read tarot cards, was occasionally able to consciously control his dream experiences during his freshman year of high school, and also wrote some metaphysically inspired fiction during this time.

After a breakthrough in 1993, when a former NASA scientist revealed to him (through a friend) that UFOs were indeed real and that humanity had secretly reverse-engineered the technology, he became fully interested in the study of ufology and metaphysics. as much of his free time as he could create. During this time he also honed his musical skills as a percussionist and composer with a minor in jazz studies.

Shortly after graduating from university in 1995, he came across the book "Odjinud" by Dr. Scott Mandelker, which discussed the topic of extraterrestrial souls, or "Wanderers". Much of the material in this book regarding the characteristics of the Wanderers perfectly matched David's personality traits, and he was intrigued that Mandelker placed such emphasis on an obscure series of channelings from a woman named Carla Rueckert called "The Ra Material" or "The Law". of One", which were broadcast in the years 1981-1985 and which we have already talked about at length in the second chapter.

By January 1996, he owned all the Law of One books available at the time and began to study the data intensively, finding that he was quite close to it. In fact, he refers to it on his website as "the penultimate source of UFO wisdom."

Four years of daily dream recording and analysis, followed by intensive study of the Law of One material, provided the final gateway to tune his mind for direct

extraterrestrial contact in November 1996 at age 20.

He definitely never expected to get something like this. , as his interests were more in scientific research than channeling, and the Law of One series was the first channeled work he took really seriously.

He describes his method of gathering information as somewhat similar to lucid dreaming, where he is spoken to by entities outside of physical view while in a dream state, but remains conscious enough to speak while it is happening. Unlike Cayce, Wilcock did not have to fall into a deep sleep to transmit his information. His channeled source offered quite a bit of premonition type material, alerting him to the reality of the Ascension and the changes that would occur in the future. At times he made very accurate predictions regarding his personal affairs, world events and politics.

As we have previously reported, Wilcock communicated daily for a year before being told he was the reincarnation of Edgar Cayce in November 1997. This alone shook him to the core and in many ways he wished it very much. it wasn't true because he was very scientific and knew it would expose him to extreme ridicule. Yet, because he held the Ra material in such esteem, another nearly 14 months passed before he was directly informed of any connection between his work and that of Ra.

Had he been given such information earlier, he might have felt slightly overwhelmed, as he was already aware of the Ra-Ta story and the fact that Ra had apparently worked with him during the Egyptian/ Atlantean period. So on January 3, 1999, he received the following information from his source, and you can almost hear his exclamation of disbelief:

Ra: The planet Venus was created as our starting point, designed to open up and develop opportunity where there would be possible to obtain the source body of a new race. The identity of Ra is ours identity. We are the social memory complex you are after they strove. We wanted to talk through this

tools with the ultimate desire for increased precision and contact over a period of time. Now we feel it is okay if you have knowledge about the nature of the source. It's not like Elvis Presley where the superstar died and can't come back. As you know, we have stated that we will be in the fifth dimension and we are eagerly anticipating further service attempts that we may make.

D: If it really is Ra, then why is it so difficult for me to be able to go deep enough to receive your unfiltered guidance? Why do I have to do it consciously when it seemed so impossible to Carla?

Ra: The warping of space and time is not yet something you understand, and yet we were able to crudely manipulate its deformations to create entirely new matter. This new matter centered around the idea of unblemished seniority and created a feeling within that was vibrationally compatible with those spheres of energy that are inherently all around you. Regularly speaking, we find that we have an opportunity to come up with an entity that is able to generate such a maximum desire to serve, and it is at this time that we are then able to produce the greatest results.

At the time of said readings [namely the Ra material in 1981] it was believed that this situation would be the only ideal circumstance through which contact could be made, but we have found that to be a mistake. This has also proven to be a place where we are able to continue to allow ourselves messages without the need for an elaborate process of deep unconscious trance work. Of course, as you know, our reports are somewhat filtered, so the final product is not always the same as what you see in the Ra material mentioned.

But don't doubt yourself to know that you've actually created a lot of comparable material with us and that it's also a representation of the intermingling of foci between our level and your own. It was through this intermingling of dimensions that we were able to strip away a little more of the learned edge we had in the Ra Material and instead transform it into a more complete form here and now.”

It is also interesting to note that this announcement was within two weeks of the anniversary date that Ra began speaking through Carl Rueckert, January 15, 1981. Additionally, the time interval between the two dates is 18 years, and physicist Ray Tomes' research into the cycles of time, that is the number 18, which often separates events that are harmoniously related.

Now that we know Ra's was working directly with Wilcock behind the scenes, we need to back up a bit in the timeline. Wilcock was living in upstate New York when his channeled source asked him to move to Virginia Beach, Virginia in 1997.

Virginia Beach happens to be where Edgar Cayce lived most of his life and is also home to the Association for Research and Headquarters of Enlightenment (ARE), dedicated to the preservation and distribution of Cayce's material.

Wilcock initially assumed that this request was made because Edgar Cayce had already designated Virginia Beach as a safe area in the event of world cataclysms. After some "friendly coercion" from his readings, Wilcock decided to make the move. I will now insert an unpublished part of an interview I did with Wilcock for *Spirit of Ma'at* magazine :

David Wilcock: "Now just before I did it, not quite two weeks before i moved i this mine

a friend called on the phone and said, "You have to come to my place home. You must see something."

I didn't want to go, but he said, "You really have to come and see it now." So it turns out that he was a member of the ARE. I attended several "Seeking God" study groups at his home based on Edgar Cayce material from his later years. So I walk in and he brings me to the table and slaps this magazine with the white paper on top.

A square has been cut out in the middle of the paper, and inside the square is an image of a person's face. As he slapped the magazine on the table, he said, "Who is that?" I looked at it and I was like, "Oh my God! That's my face," but obviously I knew it couldn't be my own face, for two reasons.

First, it was on the cover of a magazine and I never published it, and second, it was done in an art style where it was part photograph and part colored pencil.

I thought to myself, "That's not me." Then I continued by saying to myself, "Okay, well, he's obviously an ARE member. This is typical of the type of artwork you would see on the cover of ARE 's *Venture Inward* magazine. Therefore it must be a picture of Edgar Cayce when he was young." So I finally said, "Well, that's Edgar Cayce," and he said, "Well, yeah, but who else is that and who else does it look like?" And after a long I said in silence, "Wow, that's pretty weird."

So when I came to Virginia Beach, people who worked at ARE in various capacities came up to me and were amazed at my physical resemblance to Edgar Cayce, which is quite astounding as anyone can see from the photo. So this type of event started to happen more and more often.

Without going into all the details, let me just say that it finally it came to a crescendo where my reading said: "You have to tell me. Is it true or not? What's going on?" He had to I ask two or three times before I actually got it answer. When I got a reply, they said, "Well, we're willing to tell you, but you have to understand that he comes with this answer great responsibility."

It's funny because if you actually read the reading there, where they tell me, there's some sort of argument going back and forth between us, where I'm like, "Man, if that's true, then I'm in some real rough times. No one will accept this. No one to that he won't believe."

I've always hated hearing about people who in their pasts They claimed to be famous all their lives, and then I didn't tried to use it to others in the metaphysical community added some credibility. I was already aware that Cayce went through some very grandiose past lives, including the Atlantean High Priest Ra-Ta, and that the return of Ra-Ta was predicted in 1998. Never in a million years did I

he couldn't imagine that I would be like this. person. On one side it was quite exciting, but on the other hand, I it felt like a death sentence.

Basically, however, they told me that if I didn't let them know and unless I start promoting my work as a private channeling and I won't try to get it out into the world, for example through the Internet, then I basically committed the equivalent of a crime in the spiritual realms. Suddenly I had feeling like all this responsibility is thrust upon me and I can't to say that I would enjoy it. That which was always mine the novel's little secret, suddenly acquired on Earth appalling importance.

Now I wasn't just David Wilcock, I was reincarnated a historical figure whose previous work they knew and revered millions of people around the world. Although I was really enough clairvoyant and I was getting all sorts of information which I wasn't aware until I transcribed my tapes, Edgar Cayce was widely regarded as "the most accurate clairvoyant of all time" outside of Nostradamus, and those were just a few. really big shoes to fill.

This created the possibility that my own work, character, purpose and fate will constantly be judged against Cayce, instead of were accepted on their own merits. I felt, that I can already see those scornful faces and hear howls of protest when I followed my instructions to post this information.

If we are to evaluate whether David Wilcock is indeed the reincarnation of Edgar Cayce, we must consider whether the preponderance of evidence would lead a reasonable person to that conclusion. I discovered Wilcock's website in the late 2000s and my first thought was that it was absolutely impossible for him to be the reincarnation of C

Cayce was one of the biggest influences in my life and it seemed absurd that he could come back and that I had discovered him now. Still, I was intrigued by the extraordinary similarities between the side-by-side images that compare Wilcock's portrait with that of Cayce as a young man. I have read a few of Wilcock's channelings and I understand that there is a lot of wisdom in them. So it would

you could say I was hooked. I began to study Wilcock's site in earnest and soon had a reading schedule.

The first thing I noticed when studying Wilcock's pages was that they were somewhat disorganized. (At the time of this writing, it was starting to improve.) And when Wilcock posted a transcript of one of his readings, it was often interspersed with dream data from his lower consciousness. I found it all hard to read and confusing because there would be great leaps of consciousness from paragraph to paragraph as he oscillated back and forth from his personal dream to the information being transmitted. Still, I continued my studies, taking a neutral stance and believing that the truth would eventually surface if you really found it.

I bought some of Cayce's books and read them aloud, especially the information about Cayce's past lives. If Wilcock was in fact Cayce, then I would expect to find many correspondences between Cayce's psychic abilities, personality quirks, and the recurrence of past life relationships in Wilcock's current life. The rest of the first part of this book will report on what I actually found, and I'll leave it up to you, the reader, to make up your own mind.

Cayce gave a fairly extensive history of his own past lives in his readings. In studying these lives (WH Church, *Many Happy Returns*), I was surprised to find that they were not consistently on an upward spiral to higher consciousness, contrary to what one might expect. For example, in one life he might exhibit a high degree of spiritual awareness and service, while in a later life he might be a scoundrel and a womanizer. According to the Cayce Readings, as we discussed in Chapter 3, Cayce was a high priest of Ra-Ta in Egypt with many psychic and healing powers.

Much later, in eighteenth- and nineteenth-century America, Cayce reincarnated at *two different times* as a man named John Bainbridge, who was a gambler, vagabond, and womanizer. His desire for escapist behavior was so strong that once he drowned the first time, he felt compelled to go back and do it

all over again, even under the same name. However, at the end of his second incarnation, he gave the last meal to a starving child, saving him and sacrificing his own life. According to Cayce Readings, such a selfless act of love alleviated much of the karma he had accumulated as Bainbridge.

And finally he incarnated as Cayce, the first clairvoyant/mystic in the history of the Western world. In each life, Cayce seemed to have a different role to fulfill or a different karma to resolve. But even in John Bainbridge's life, he used his amazing psychic abilities to beat his gambling partners. Apparently he was able to tell what cards the other players at the table were holding. Cayce even demonstrated the same mind-reading ability with playing cards to his son, Hugh Lynn Cayce. More impressively, Bainbridge could teleport a pea from one shell to another in case someone beat him at his own shell game, but Cayce did not demonstrate this ability.

In his readings, Cayce predicted that he would return in 1998, the passage that opened this chapter. Many Cayce devotees interpreted this to mean that Cayce would be reborn in 1998. However, Cayce did not say that he would be reborn: he said that Ra-Ta would return. Wilcock was told in his own trance in late November 1997 that he was an incarnation of Cayce. And 1998 was the year Wilcock introduced himself (but was not taken seriously) to the ARE (an organization founded by Cayce to preserve the information in his readings.)

So with this in mind, we shouldn't expect Wilcock to be a carbon copy of Cayce. He is in a different time period and on a different mission. But from a larger perspective, his current mission is entirely consistent with that of Cayce, albeit in a different form of expression. His soul has already proven that psychic abilities are real, and due to his high degree of accuracy, has also strongly indicated that the Earth is preparing for a massive energy transformation beginning in 1998.

However, the fruits of this work were shot down by the scientific mainstream, which monotonously chanted that such phenomena were "impossible" because they would "violate the laws of physics". So it's no surprise that Cayce would return in a form that would allow him to completely rewrite these laws of physics using known scientific data that had been published by Ph.D. level researchers to create a unified model of the universe that validated all of his work as Cayce . Remember that Cayce didn't even come close to finishing high school due to his duties tending to the family farm, while Wilcock incarnated with a Ph.D. a physicist grandfather and a highly intellectual family.

Interestingly, after four years of being aware of this connection, Wilcock still wasn't too concerned with convincing anyone that he was the return of Cayce. Instead, he has been very busy creating a body of work that stands on its own in the face of scientific scrutiny. His website has received more than 200,000 unique hits at the time of writing. He has written five online books.

And without mentioning his famous predecessor, he has had several speaking engagements, notably more than one appearance on Art Bell's Coast to Coast radio program with an estimated two to four million listeners the night he appeared. He is also the director of research at a national seminar with Dr. Scott Mandelker called *"Time of the Global*

shift', which provides a live multimedia presentation that outlines the energetic changes currently occurring on our planet and solar system and shows how it relates to ancient prophecies and the UFO phenomenon.

So let's now give a quick overview of what it does David Wilcock, which causes so much interest in his work. First and foremost, it is psychological. He claims to be communicating with an entity from another dimension who identifies himself as Ra. Wilcock receives Rao's communications while in a semi-conscious trance, which he then records and transcribes. This has been happening since 1996 and

many of these "Ra" values are published on Wilcock's website.

One of the roles Ra has taken on with Wilcock is that of teacher and inspirer. Many of the previously published readings deal with how Ra helps and supports Wilcock in overcoming what you might call his lower self pattern, such as his early college history with drug use and preoccupation with sex. Some of these transcripts read like a wise father giving advice to his son.

You have to remember that these readings began when Wilcock was barely out of adolescence. We all know Cayce as an older and wiser being. It might seem incongruous to imagine the reincarnation of Edgar Cayce battling the inner demons of drugs and sex, but you'll see how the pieces fit together as we progress, all the while realizing that Cayce's decadent previous life - John Bainbridge - was quite recent .

Another very significant data point is seen when we compare the planetary positions at the time of Cayce's birth with the planetary positions at the time of Wilcock's birth. Wilcock has yet to find any astrologer who has ever made a more convincing case for reincarnation based on astrological connections. Both Cayce and Wilcock were born in the year of the buffalo in the Chinese zodiac, which itself can only occur once every 12 years.

Furthermore, the positions of the Sun, Moon, Mercury, Venus, and Mars at the time of Wilcock's birth are literally almost identical to their positions at the time of Cayce's birth. All the outer planets have some unique and very narrow angular relationship to each other, such as 30, 60 or 90 degrees. Astrologer Brian Mc Naughton has independently concluded that there could not have been a more favorable time for Cayce to reincarnate during the 127-year period than on the exact date of Wilcock's birth, March 8, 1973. Once the facial similarities are factored into astrology, the likelihood that this is all pure coincidence , is... well, astronomical.

Wilcock also does readings for others through his feed. If he has the energy, he does a maximum of about four readings a week, but unlike Cayce, Wilcock's readings do not deal with health issues or past lives; it primarily addresses questions of how a being can better connect with its soul and fulfill its life purpose. As a recipient of one of these readings, I can attest to the high degree of wisdom that was imparted and Ra's inner understanding of my own fundamental life questions.

In studying Cayce's own readings regarding his future lives, I came across the following two predictions:

Cayce: "He saw himself back in Virginia Beach." (From Cayce's reading mentioned in Church's book about his own future incarnation.)

Wilcock was eventually very strongly urged to move to Virginia Beach before he was aware of the Cayce connection. The move was prophesied in the readings almost from day one, and Wilcock was just beginning to sense the possible connection when he arrived in Virginia Beach. His readings predicted the exact name of the street (Great Neck) he would live on in July of that year, a move that didn't take place until October.

That July they also gave it the German phrase "*Scarstahldig*", which turned out to be "*a group of German steel helmet*". (Wilcock never studied German.) Amazingly, the second tenant living with the woman Wilcock first moved in with in Virginia Beach was a collector of German steel helmets! Moreover, this man had not even heard of the property when the reading took place in July. Just two months after Wilcock met the man, the man discovered that his entire collection of helmets had been stolen from his warehouse.

Cayce: "Surrounded by many of those who were with him in the earlier one by the time..." (Again from Cayce's reading about his future incarnation.)

Cayce predicted that when he returned in 1998, he would be surrounded by many of his former associations. Wilcock believes he has confirmed this because he recognized many of the relationships in his circle as repeats of previous associates. Often from reading it

strong hints of these connections fell out before he even realized what he was being told. In some cases, he was able to compare photos of people in his current life with relationships from past lives and found shocking facial similarities, as seen in Figures 5.3 and 5.4.

Chris R and Jude G are two of David's oldest and closest friends that he still keeps in touch with, so these weren't just random choices. (As discussed in the previous chapter, Dr. Walter Semkiw recently completed a study suggesting that there is a facial similarity between the current appearance and the appearance in a past life.) Wilcock believes that he has identified the Cayce reappearance to comrades such as Morton and Edwin Blumenthal, David Kahn, Dr. Wesley Harrington and Leslie Cayce (Edgar's father.)

Summary of important points:

1. The pieces start to come together. A higher dimensional being — Ra — is dedicated to serving the Earth. Ra first appeared 75,000 years ago and worked (speculation) with Edgar Cayce's previous Ra-Ta incarnation in Egypt 10,500 years ago. There are indications that Ra was the channel that allowed Cayce to receive such amazing information in his dreams. Ra was received and transmitted by Carla Rueckert from 1981-1985 when much parallel and correlational data was transmitted to Cayce values.
2. A young man named David Wilcock, who looks almost exactly like a young Edgar Cayce, exhibits psychic and precognitive

abilities and is psychically informed that his source is Ra and that he is the reincarnation of Edgar Cayce.

3. Wilcock fulfills Cayce's prophecy of the return of Ra-Ta in 1998. He also fulfills the other conditions of living in Virginia Beach and having his old Cayce companions return to his sphere in this present life.

Appendix: A Concise List of Wilcock's Best Evidence

CAYCE'S ATLANTEAN PAST LIFE AND PROPHECY RETURN

Those who have studied Edgar Cayce's work in detail know that he had an important past life as an Atlantean priest known as Ra-Ta, who was responsible for transferring the knowledge and records of Atlantis to Egypt, as well as assisting in the design and construction of the Great Pyramid. And as Dr. Chet Snow in his 1989 book, *Mass Dreams of the Future*,

In a 1934 reading [number 294-151] [Edgar Cayce] predicted his own next incarnation here on Earth in 1998. At that time he will return as the "liberator of the world" and help those souls not yet enlightened to understand the meaning of the New Age, which will include the Second Coming of Christ. In this way he will play a role similar to the one he described that he once knew in Egypt as the priest of Ra-Ta.

BRIEF FAMILY PORTRAIT OF DAVID WILCOCK

David's great-grandfather, Frederick Wilcock, had a Ph.D. from Harvard University in Mechanical Engineering and an M.B.A. from Brooklyn Law School, and was the principal architect, engineer, and legal advisor responsible for the design and construction of the New York City subway system under the East River:

*"The 1910 [Brooklyn Law School] textbook allows look a little deeper into the diverse background and of student personalities... **Frederick** ("Fredy") **Wilcock**, born c England in 1873, graduated from Harvard and was a builder Engineer and Chief Assistant to the Public Service Commission for the construction of the [New York City] subway under the East River."*

[It is very interesting to point out that Ra-Ta was directly responsible for the extensive tunneling under the Giza Plateau in Egypt, which is only beginning to be discovered and recognized by the mainstream. Giza was to the Ra-Ta period what New York is to our period. Wilcock didn't learn of his great-grandfather's accomplishments until his own grandfather was two months old from his death, and said it was a "family secret" he didn't want to brag about. The truth is, Frederick died when Donald F. was 12, and he always felt overshadowed by his father's achievements.]

David's grandfather, Donald F. Wilcock, also had a Ph.D. in mechanical engineering and held many patents, including the design of the bulletproof turret that is now a part of almost every helicopter in the area where the wings join the body. He also designed computer programs in Fortran for various engineering problems.

He was very skeptical of David's findings, but began to consider them more seriously in the last year of his life, saying, *"You know, if you are right about all of this, you definitely deserve a nobel price..."* Dr. Wilcock encouraged David to expand his findings of the solar system into the larger perspective that can now be seen in *Divine Cosmos*.

David's father, Donald E. Wilcock, chose the field of journalism and, in addition to a wide range of publishing endeavors, including magazines and newspapers, wrote the popular book "Damn Right, I've Got the Blues," which shows how rock and roll music was inspired by American blues music of the early 20th century. ~~century and quite~~ the guitar work of Buddy Guy when he was still a young man.

His "Northeast Blues Society" has its own publication, which he writes and designs, and is responsible for the regular

booking and organizing very well-attended concerts. During his career, he literally interviewed thousands of the world's most famous musicians, and during his teenage years, David had extensive experience with celebrities, being taken backstage at concerts about once a month.

Both David's maternal grandmother and grandfather were teachers and devout Christians.

David's mother, Marta Waterman, is a piano and voice teacher and professional musician who performs in New York, Florida and Europe. She amassed a substantial library of metaphysical texts that David began to consult at a very young age, and is directly responsible for David's perfect height and musical talent, as well as teaching him spiritual principles.

David's brother Michael Wilcock is a talented artist, musician and teacher with a BA from Syracuse University. He had recently experienced direct extraterrestrial contact through a ball of light that entered his room, expanded into a seven-foot-wide ascending vortex on the ceiling, and then told him, "The ascension your brother writes about does not happen all at once... it is a gradual process, accompanied by feelings, like the ones you're experiencing now." 12 hours *after* it happened, Wilcock saw a UFO in daylight and said, "Now all I need is for a ball of light (ET intelligence) to enter my room. Little did he know what happened

CHRONOLOGICAL LIST OF WILCOCK-CAYCE CONNECTIONS

When David was an infant, his mother could not leave the apartment for a moment without him crying, even when he was asleep.

David was very restless and upset in his crib whenever Watergate news came on TV.

From about age 2 onwards, David had epic dreams related to UFOs and Atlantis and would wake up in despair, longing to be back.

David also had spontaneous flashbacks of grandiose, multidimensional experiences as a young child that were triggered by things such as certain houses, certain objects and toys, certain places, riding the bus, etc. These triggers put him into deep altered states where he knew he was here to carry out a high-ranking spiritual mission on the planet. The experiences usually lasted about a minute and a half or two minutes, and when they were over, David had a hard time understanding what they meant with his rational mind.

At the age of 5, David has a fully conscious out-of-body experience where he walks feet first out of his room and down the stairs, about a foot below the ceiling, before becoming afraid and returning to his body.

David felt like he was being taken somewhere where it was important that he didn't feel fear, so he had a strong desire for "one more chance."

David's mother was into metaphysics, having already read "The Nature of Personal Reality" by Jane Roberts under the title "Seth" and the entire series of books by Carlos Castaneda. She was convinced that David could learn to do OBE consciously if he really wanted to.

David's desire to induce another OBE led him to read his first adult metaphysical book, "How to Make ESP Work for You" by Harold Sherman, at the age of 7.

During the first week of reading the book, David remotely influenced his friend Eric to wake up in the middle of the night and think of gold as his first thought. Eric reported waking up in the dark of night and feeling a strong presence in the room. The first thing that came to his mind was his watch, which was gold. David had no idea that Eric was using a watch, not a clock, as he had never visited Eric's bedroom in his waking life. He confirmed all these details at noon before telling Eric what he had done.

David put together a team of friends who would go around the corner of the kindergarten building and guess the number 1-10. David had 100% accuracy in getting the numbers right. This experiment was only done once because the other boys were scared.

David had an undying belief that he could put the rope under his feet and then pull himself very violently to either side and he would levitate. He spent hours trying to do it in the driveway or on the playground because in his dreams it worked effortlessly.

Three or four times a year David awoke in the night with a tremendous internal pressure centered around his ears and front of his head, which he felt like a thunderclap. At the same time, he was experiencing hallucinations where everything he saw in three dimensions was rendered on a grid of luminous light. Sometimes the grids changed shape if he focused his thought on a certain area.

He always tried to stop the experiences by trying to scream louder than the "noise" in his head. His mother held him and sent him healing, nurturing energy through chanting for 10-15 minutes to stop the visions. This experience happened in the same way about 20 times in childhood.

In his second grade class, David demonstrated his psychic abilities with a handmade deck of cards that had numbers, words, and pictures on them depending on the card. He managed to get a few accurate "hits", but not as many as he would have liked. The teacher was glad he did.

The second and third books David read at age 7 were both about hypnosis. David felt that hypnosis and psychic abilities were somehow strongly connected. He brought these books to school with paper over them so he could read them freely while the other children continued to read 22-point picture books.

David was able to fix a number of appliances that broke down in the house simply by taking them apart, studying them and performing

changes. His first success was fixing a dryer and his skills improved when he learned to use a soldering iron.

David was convinced that other people could hear his thoughts just as he could hear theirs, so he would try very hard not to think negative thoughts about anyone if they arose.

At the age of 8, David heard his brother talking in his sleep and sensed that important information would be passed on to him. He tried to set up a tape recorder to pick up these voice-activated fragments and had some measure of success. He felt that in this state, Michael could potentially answer any question they asked him, even though they only slept in the same room on vacation, so he was never able to 'catch' it at the right time.

Also at the age of 8, David took a walkie-talkie and held it to his father's ear with the volume knob set to 1 while his father was dozing on the couch in the living room. Then he went upstairs and broadcast news about how delicious the sausage and mushroom pizza was going to be on the walkie-talkie at low volume. Then he went back downstairs, whereupon his father woke up from his sleep and said, "Okay boys, how about we go get a sausage and mushroom pizza?" This scientifically confirmed to David and his brother that hypnosis and the power of suggestion really worked.

David kept reading Sherman's ESP book over and over again. In the winter of 1981, still at the age of 8, David affixed an American Lung Association Christmas stamp above a chapter titled "Your Healing Power" referring to the use of ESP for healing. This, of course, was what Cayce did with his powers in a past life. David didn't think at that moment how to prove that he had read the book when he was still young.

David developed a technique he called "pulsing" to suddenly send a high degree of psychic energy to a person. One day, he was harassed by a bully on a bicycle while walking home from school. As the tyrant drove away, David pulsed into him with an energy of malevolent rage and

The tyrant promptly flipped his bike into a ditch, then quickly got back on his bike, more embarrassed than hurt.

David went home and cried and apologized to God for misusing his powers and never again "pulsed" anyone for negative reasons. [7/1/02: Upon further reflection, it turns out that this is not entirely true. A few years later, in about the 5th grade, David walked with his parents down a busy sidewalk on a summer vacation to Cape Cod, Massachusetts. A man in his early 20s rode his bike too fast through a crowd, creating an almost guaranteed likelihood of hurting someone.

David locked into the man's eyes with great anger for a split second, and the man instantly flipped over and fell off the bike, sliding about eight feet down the sidewalk without hurting anyone but himself. David spent a long time discussing this event with his parents and came to the conclusion that it was somehow an activation of his own karma due to the strong possibility of causing serious injury or death to a young child at the rate he was going. David's father, ever the skeptic, believed there was no connection between the two events.]

David was able to repeatedly return home at the exact minute his mother asked him to after going on bike trips without a watch or checking the position of the sun. His friends would be very surprised if they walked into the house at, say, 5:00 a.m. sharp. That was the norm, not the exception. On other occasions, when his mother wanted him home but didn't specify a time, she would go out to the end of the driveway and "Send" him, as she called it. Both he and his brother would feel these calls and return home within five minutes.

David could throw the sticks in the air and then decide which way to make them point when they fell, which they would then do very reliably. He broke the stick on one side so that it made a clear arrow and for the experiment to work it would need to have an exact 360 degree orientation.

On several occasions, David and his brother were able to use psychic powers together to create rain or start blowing wind.

David was enrolled in the Pyramid program for gifted children at school and did independent projects in chemistry, astronomy, stargazing, computer programming, crystals, and multimedia planetariums before sixth grade.

Despite being an A student in all other subjects, David refused to memorize multiplication and division because he felt strongly that you always had to recalculate them every time. This is of course a recollection of a multidimensional existence where mathematical laws were malleable depending on the coordinates of time, space and dimensional frequency in which the entity was located. Although it didn't cause him any trouble in timed math tests. from third through sixth grade, he scored exceptionally well on COGAT tests and placed in math, English, and science in middle school and Jr. High.

David took the SAT in 7th grade and scored 580 verbal, 610 math, outperforming more than 95% of high school students.

David has experienced many accurate psychic results using Ouija boards, palmistry and tarot readings since 7th grade based on his studies. In 9th grade , he stopped using the Ouija boards due to studying the Tarot, which consistently provided fantastic accuracy and insight.

David read a book in 7th grade called "Body Language" that had a huge impact on his life. The book described how the subconscious communicates a person's true feelings through body language. He immediately began to realize how often this would provide information about people's emotions and learned many new things about interpersonal and group dynamics. This also led him to want to become a psychology major in college.

David had a poor diet and started in 6th and 7th grade after his parents divorced be overweight. His favorite food at the time was pork hot dogs. Cayce also had a weakness for pork.

At the age of 15, David succumbed to peer pressure and started using marijuana sporadically, which continued until he quit "cold turkey" at the age of 19. He experienced very intense psychedelic states where he visibly detected geometric patterns of Light, experienced "instant knowledge" of cosmology, and astrophysics, he had a deep and profound awareness of the scandals in the government and the damage that was being done to the environment, he had a strong sense that an incredible energy shift was coming to Earth, and he audibly heard phenomena that later became useful in his channeling work.

When David was 16 years old, he went on a strict diet and consistently lost 85 kilos in nine months and then never gained it back.

At age 16, David read "Lucid Dreaming" and "Exploring the World of Lucid Dreaming" by Dr. Stephen LaBerge. He was quickly able to use the "mnemonic induction of lucid dreaming" or MILD technique to access fully conscious dream states where he could levitate, fly, travel through solid objects, perform stunning feats, change his entire surroundings in an instant, temporarily fulfilling his greatest wish and speaking with higher beings while realizing that he is out of body. Some of these dreams brought him to the main deck of an alien spaceship.

During the same time period, David asked his friend Jude to perform a dangerous hyperventilation technique that cuts off oxygen to the brain. The technique was only supposed to be done for seven seconds, but David wanted Jude to do fifteen.

David's body collapsed and he was unconscious for about ten or fifteen seconds. His own experience, however, was that he moved to a completely different life in a mud hut by the river. He had the experience of 24 years of subjective time, viewing the highlights of this life in a linear sequence. At the time of his death in this life he saw his face, which looked similar to his present face, but with the nose and lips of an African.

It was the first time he remembered who he was during that experience. Later, his data confirmed that he was moved into a past life review so that he wouldn't see his body lying there in an OBE and fear that he had died. The ensuing panic could have threatened his return to the body, which was suffering from immense pain and dizziness. Lifespan was at the beginning of Sumer and does not appear to be covered by the Cayce Readings.

David read "Secrets of Shamanism" and realized how seemingly random events can actually convey a message in symbolic language when properly understood.

At the age of 16, David experienced his first "ear shot" (actually a sudden, crushing energy pressure in the frontal lobes of the brain caused by an energetic activation) precisely as the clock struck 3:33. This still happens to him every other month on average. The experience is completely depersonalizing, with massive kundalini energy shooting up the spine. Historical Catholic accounts of "flying saints" stated that they would get the exact same sensation before being able to levitate, but David never demonstrated such an ability.

At the age of 17, David wrote the first of three short science fiction novels, where some of his experiences were processed and written in an entertaining and readable way.

From early childhood until the beginning of college, David had occasional experiences of walking and talking in his sleep. His parents recalled one occasion when, as a small boy, he walked into the bathroom in a trance and was very insistent on finding "phone books"—a metaphor for contacting the Higher Self.

David sat up in bed several times during his first year of college and spoke directly to his roommate while he was still asleep, on one occasion referring to "water"—another metaphor for spiritual energy. David recalls many occasions when he woke up, showered, packed his bag, ate breakfast and walked out the side door to school, only to realize that it was full outside

dark. Only then did he realize that he had been in a trance the whole time and had not registered the times he had seen on the clock.

During a high-potency marijuana-induced trance in college, David was able to play Yahtzee with his teammates and roll sixes over and over. The minimum number was three, often four or even all five dice were sixes. It happened at least 10 times in a row. The whole time he was doing it, he was putting on a southern accent and had a playful attitude about it. Once he started, he couldn't get the dice to roll any other way, even if he wanted to get other numbers to stay competitive in the game.

An incredible constellation of synchronicity led David to stop using marijuana on September 21, 1992, just after his sophomore year of college. Just a few days after he finished, David spontaneously wrote a 22-page essay about Earth as a giant experiment where each person learned lessons through free will while being watched by "experimenters" who were higher beings.

He was now convinced that such beings must exist. He also began writing down his dreams in as much detail as possible every morning, almost never missing a single morning—a practice that continues to this day with only one major interruption from late 1993 to mid-1994. There are now more than 5,000 pages of transcribed dreams and psychic readings.

Over Thanksgiving break in 1992, David was sleeping over at his friend Jude's house. David had a waking dream vision of being chased by a monstrous fat person who represented his own unresolved issues from being overweight. In the dream, he had a gun and could have shot the man chasing him and stopped the battle, but he didn't want to, instead choosing to keep running.

Jude stirred in his bed, fast asleep, and said, "Shoot him... Just shoot him. Two bullets." David didn't say anything out loud

indicated what his vision was. David eventually realized that Jude was the reincarnation of Edwin Blumenthal, who, according to the reading, was said to have the potential for great psychic gifts.

In December 1992, David was hanging out with his old marijuana buddies and told them he quit smoking because he felt he was here for a prominent public role as a spiritual leader. They doubted him so violently that he finally ran out of their house. At the intersection of their streets and his, David stretched out his hands on both sides in the pattern of Jesus, looked at a place in the sky and said, "I don't care what anyone thinks. I know that I am here on a very important spiritual mission and I will carry it out." As he said this, a shooting star flew directly across his field of vision and he had a tremendous "kundalini" experience that went from his feet to the top of his head, making him tremble in ecstasy.

In April 1993, David's friend Ray revealed that his physics professor had worked for NASA in the 1960s and early 1970s and that it was "common knowledge" "in the upper echelons" that an alien spacecraft had crashed on Earth and that the technology had been reverse-engineered . make fiber optics, LED lights, Teflon, Velcro, Kevlar, infrared night vision, lasers and computer chips.

Other technologies found included room-temperature ceramic superconductors, compounds engineered directly at the molecular level, outstanding nanotechnological achievements, anti-gravity and near-light-speed propulsion, and free energy generation. Three main types of aliens were found inside the vessel, the tallest of which was almost indistinguishable from normal human beings. Knowledge was to be revealed to the public gradually to avoid fear, never with a bold official statement "on the front page of the New York Times".

The "NASA Disclosure" event profoundly changed David's entire life. He decided that since the UFO phenomenon was in fact real, there was no better use of his time than to

plug into his massive studio. David began reading five books at a time, finishing one or two a week, which continued from mid-1993 until mid-1996, when he began to switch to extensive internet research. He also solidified his decision to stop watching television altogether, which began in 1991 after entering college.

In the fall of 1993, David's friend Ray revealed to him Richard Hoagland's work on the Mars monuments. David read a book he subsequently bought and was absolutely fascinated by the sight of geometric alignments that had been discovered between Martian monuments, the plateau of the pyramids at Giza in Egypt, and certain crop circle formations such as Barbury Castle 1991.

All these alignments described the concept of a tetrahedron, a four-sided pyramid made of equilateral triangles, placed inside a sphere. One tip of the tetrahedron would be at the north or south pole, and the other three tips would emerge at 19.5 degrees above or below the sphere's equator. Hoagland then showed how there was an increase in energy at this 19.5 degree point in the Sun and almost every other planet in the Solar System.

These risers included giant volcanoes on solid planets and cloud belts and cyclonic storms on gas planets such as Jupiter's Great Red Spot and Neptune's Great Dark Spot. David spent countless hours trying to figure out how a planet could be ruled by forces in the form of a geometric object. This, of course, was knowledge he had already applied in his past life as Ra-Ta, an Atlantean Egyptian priest, and would eventually become the cornerstone of his own scientific research.

Shortly after finding Hoagland's work, David found "The Great Pyramid Decoded" by Peter Lemesurier. He was also deeply impressed by this book, as he realized the full range of technology and design knowledge that had been implemented in the construction of the pyramid. He also detailed how the language of mathematical symbolism was used to create

timelines for major events in human civilization that have already demonstrated extreme accuracy in the past, such as the birth of Jesus and the timing of world wars, and continued further into the future, prophesying great spiritual changes ahead.

David began experiencing "numerical synchronicity" almost constantly. He looked at the clock just as it read 3:33, 4:44, 11:11, 12:12, etc., not knowing what time it would be. It happened at least once or twice a day, and it always seemed to be a favorable response to whatever spiritually inclined thought David was having. After college, it also regularly appeared on license plates, health food store license plates, and the speedometer of his car while driving.

In his senior year of college, David began dating a Japanese girl named Yumi, who woke up several times in a trance and gave him messages. Two of these reports involved being told he was "shining" while reading books such as "Aliens Among Us" by Ruth Montgomery.

The most interesting news was when she woke up, she was apparently stroking something in her hands and said "Kon no waraji ro katandakedo". David quickly wrote it down and then repeated it to her in the morning. Translated as "Look at these new warajis (sandals) I just bought. The problem was that warajis are ancient Japanese sandals that haven't been around for over 700 years!"

In December 1994, Yumi returned to Japan over winter break and showed David's picture to a very trustworthy and very accurate Shinto priestess and psychic. The woman immediately said, "*This man will be very famous. A spiritual leader. Famous spiritual leader.*" David was obviously very surprised to hear this.

During the week that David heard this feedback from the Shinto priestess, he and Yumi attended a concert featuring a Siberian shamanic throat singer. The woman could sing in a low, growling voice and a shrill scream at the same time, and make her voice sound like it was coming from any part of the auditorium.

David closed his eyes and began to meditate in the front row. At the end of a long, deep breath, he felt a massive squeezing pressure in his chest, like a punch, and he couldn't breathe. Suddenly, he was catapulted into a visionary trance in which he saw a luminous ball of light, colored white, yellow, orange, and red, decreasing in intensity from the center. In this space he felt he had the answers to every potential question that could ever be asked and wondered what he should try to take from this area.

He was finally allowed to catch his breath, whereupon he found a woman standing at the edge of the stage right in front of him, staring at him. When he opened his eyes, she nodded her head and smiled in understanding. Cayce also reported seeing a ball of light when he entered the "Akashic Records".

David and Yumi broke up after graduating from college in June 1995 when she returned to Japan. David quickly moved back to his college town after graduation because almost every dream he had when he was with his family featured the area. He then found the book "We The Arcturians" by Dr. Normy Milanovich and it was the first time he took any of the "channeled" material seriously.

He was very surprised when the Arcturians advised a strict diet of no meat, no dairy, no white flour, no refined sugar and no preservatives, but he started doing it anyway, which took about two years to really settle in as a habit. He was already heading in that direction, having given up dairy and meat a year ago.

In November 1995, David was fired from his job in the psychiatric ward for being "too patient friendly". Immediately afterwards, he found the book "Odjenud" by Dr. Scott Mandelker, who clarified the idea of people having extraterrestrial souls.

David was very skeptical until he read the 12-part questionnaire at the end of the book, which began: "You can be an alien,

if the following questions concern you." No living person had ever understood David's inner psyche as well as this questionnaire—so he bought a book that seemed noticeably armored in his hands as he held it.

At the same time, David saw the book "The Mayan Factor" by Jose Arguelles. He opened directly to a page with a symbol he had carved into a pin in high school jewelry class. The meaning given to the symbol, CIB, according to Arguelles, was "The ability to contact and communicate with a higher intelligence".

Two days after David started reading Dr. Mandelker's book, he and his friend Jude did an automatic typing to see if he was, in fact, a Wanderer. Once a deep trance was achieved, David's non-writing hand came to life as he held the pencil and made a series of very rapid movements without any conscious thought. Immediately afterwards, David and Jude turned on the lights.

The words said "Christ is coming" and contained the Bible quote EC 40 57 which turned out to be Ecclesiastes 2:22-3:13 expressed by the number of verses counted from the beginning. "EC" was also how Cayce's readings referred to him by name on many occasions. The entire passage began and ended perfectly in line with David having just lost his job. David didn't have nearly enough biblical knowledge to make that choice for himself.

In January 1996, David prayed again for an answer as to whether or not he was an alien and went to bed before his roommate came home. The next morning his roommate Eric was woken up by an unusual early morning phone call when David accidentally started the car to warm it up before work, something he normally never did.

When David returned to the house, he was very surprised to see Eric awake, and Eric told him that he had just had a dream where a man came out of a UFO, talking about Earth Changes and Ascension, and not to worry that she had run away. The man finally threw an arm around David's shoulders and

he said, "*It is very important that you know that he is one of us.*" Eric was unaware of David's prayer the night before.

The best example of synchronicity happened twice in 1996. Both times he went to a health food store and a synchronic price came up, like \$9.99, when he didn't want to go over ten dollars but wasn't actively counting the prices of vegetables and grains. chose In both cases, he drove home "back" and experienced a combination of a three-digit clock sync, such as 4:44, along with a three- or four-digit odometer, such as 125555.

Most impressively, both of these moments took place at the exact *same intersection* on the way home, just two obscure country lanes in the middle of nowhere. David thought he might have an encounter with the UFO beings if he returned to that intersection at a certain time during the night, but he never had the courage or motivation to pursue it.

During 1996, David had more and more extremely vivid dreams that indicated that the extraterrestrial beings appearing in his dreams wanted to communicate with him in some way. He did not achieve success until November 10, 1996.

At the end of David's very first reading, the source suggested that David travel to the Mesoamerican pyramids through an out-of-body experience. When David read it a second time and came to that place, the phone rang. It was a man he met at a UFO conference who invited him to a seminar on "how to induce an out-of-body experience" that was being held that same day.

Much of the information in David's early readings was very cryptic, metaphorical and symbolic in its use of words. Much of it seemed to be garbled speech, but it also communicated some very highly metaphysical concepts. Right from the first session, there were hints that David was Cayce's return, even though he didn't figure it out all year.

One of the most egregious clues was "This is a rehearsal for our interaction near Williamsburg (Virginia)." Other clues were,

when the source said "I was born in..." and then tried to list a series of dates clustered around "1877 birth. which was the year of Cayce

The very first session also said, "*One of our women, Theresa, sibling, dysfunctional. Christian, mentally.*" Five days later, Mother Teresa had a heart attack, and the reading indicated that the heart attack was caused by extreme success that made Theresa "mentally dysfunctional."

Early in the reading, it warned David that his "road rage" was a serious problem that he needed to fix - or else. Nevertheless, it continued to happen. Finally, the car accident was "designed" and prophesied by pre-read data in coded form. The key phrase heard on Tuesday was: "*My gift to the world will be a 3 1/2 x 11 sheet paper. Expect it on Friday... 90 minutes to 10am.*"

At 8:30 a.m. on Friday, David had an accident on a slippery road while driving to a training session for his new job. The officer wrote David a ticket on a yellow 3 1/2 x 11 sheet of paper with the time of the accident at 8:30.

In the less than a week since this event, David has had several dreams of a fire, only to wake up to realize that the house across from him is indeed on fire. This happened at a time when David was feeling deeply inspired by his own readings and by the book "Seth Speaks" by Jane Roberts, which explained each new experience David was going through.

Eric was told in the first reading, "*You'll be glad to know that your student loans for New Paltz came through.*" It was strange because Eric had graduated from New Paltz the previous December and was now going to Albany for a graduate program. More than a month later, New Paltz found an outstanding \$900 student loan check for Eric and phoned his mother about it before sending it. The envelope had apparently slipped into the filing cabinet and was discovered when the cabinet was moved.

David received almost 30 different reports of Princess Di's death before it happened, in dreams and readings. David couldn't put it all together in advance, despite the vast amount of concrete information that was given. David's data

confirmed that it was an assassination due to her pregnancy with a Muslim man, the mixing of royal blood, and her general rebellion against authority.

With every job he held, David received expert advice on how to handle the environment, what to learn from it, and how long he would end up staying in it.

In early 1997, David completed his separation from Yumi over the long-distance phone, which was extremely difficult and very emotionally brutal. Shortly thereafter, he heard Japanese-sounding syllables while reading and dictated them into the tape recorder, not expecting them to mean anything. "*Yatsu wo ogoshi - k for nothing. Mo yame koroshi.*" After transcribing, the Japanese translated: "*Threatening him is not good. Now stop killing.*" David didn't have nearly enough ability to speak Japanese to figure it out on his own. He realized that this confirmed his suspicions, pieced together from dreams and visions, that Yumi had been a domineering husband to him as a wife in a past life, and that he had murdered her husband with no other choice but to throw himself on the ground. bridge and soon after die of guilt. The vision also confirmed that the husband was killed by poisoning his soy sauce. Yumi flew back to the US one last time anyway and stayed with friends, and she and David resolved their differences peacefully and lovingly.

In early 1997, David received many different visions and readings describing aspects of the upcoming Heaven's Gate mass suicide, including involvement with the alleged companion object of Comet Hale-Bopp. David also kept hearing two words that he interpreted as "Marvin's Gate" as he received this data, the reading giving an indication of "Heaven's Gate" in metaphorical form. Of course, Marvin Gaye was murdered by his own father when Applewhite convinced his followers to kill themselves.

In the spring of 1997, David joined Edgar Cayce's "Search for God" study group. He felt a strong pull toward Virginia Beach and

ARE, he hoped to perhaps attend Atlantic University. The group was led by Skip Weatherford, an early pioneer of psychic research and hypnotherapist. David demonstrated an uncanny ability to interpret and understand passages in the textbook when no one else could. Surprisingly, Weatherford lived only a five-minute drive from David's house on country roads, even though it was one of only two local ARE centers in the entire North East.

Weatherford hypnotized David privately soon after meeting him. On the very first session, David reached down and touched the crystals he always used while Skip plugged in the heater on the wall next to David. Just as David's hand hit the crystals, a 3 inch spark of blue electricity shot from the wire to the heater Skip was connecting. Skip had never experienced this problem before or since and couldn't find anything wrong. heater or wire afterwards.

During the reading, the forces apologized for their influence on the electromagnetic devices. Weatherford began asking questions telepathically and the data accurately answered the questions and communicated to Skip their awareness of what was happening.

After reading it, David wanted to show Weatherford online a new crop formation that had the shape of the Kabbalah. When Weatherford tried to dial AOL to see it, all the power in his house went out. It stayed out for exactly an hour and then lit up again. David left soon after it went out and was strangely stopped on the short journey home and given a speeding ticket. This was the reading's way of saying to David, "Don't be too proud."

David had a vision where he saw himself lying in bed reading with the words "EDGAR CAYCE: THE SLEEPING PROPHET" above his body in large letters. David saw it as just a metaphor and told him that his work was similar.

Following the step-by-step instructions, David eventually landed a good job at Mohonk Mountain House, a very high-class Victorian resort. He was quickly promoted from reception to Reservations and loved his job and the historic atmosphere.

Eric began to perform readings similar to how David's first sounded, using the same technique. He awoke while he still vividly remembered his dream and wrote down any stray bits of speech that popped into his mind without analyzing or interpreting any data. The source called himself "Michael" and spoke in a very Christian manner.

David had a bizarre German sounding phrase in July: "*Scarstahldig*". Eric confirmed that it was German, and that translated to "*a group of German steel helmets.*" David also received the words "Great Neck" a few days ago without knowing why. The consequences of these statements will be known in October. He also had a vivid out-of-body experience driving on a road that was lined with trees on both sides. It turns out to be a view of Shore Drive as one heads up Atlantic Avenue from the north where the ARE building is. David felt strongly about moving to Virginia Beach. This was then confirmed in an out-of-body experience when he met a woman with gray hair and blue eyes who told him: "*You know you have to move, that Yeah.*"

David had another OBE where he went into the Akashic Records, this time seen as an endless corridor lined with library books on either side. David went straight to the Edgar Cayce section and was amazed to find the incredible amount of information available there. His astonishment was so great that he returned to his body.

Eric was given readings in German that far exceeded his ability to speak the language. The translation read: "*Everyone they leave the lady's house. A toast to a working fireplace.*" Their landlady soon tried to get David to sign a one-year lease, forcing him to make the decision to leave. (Eric moved to another apartment and left less than 9 months later.) All the rooms that David sold to Mohonka po

phone, they had working fireplaces and David was very disappointed to find out that he was going to be laid off for the season in mid-October. . Less than two weeks before leaving New York State, Weatherford called David and said, "*You have to come to my house, Right Now.*" David arrived and Weatherford had a magazine with a white paper with a square hole cut out of it. Inside the opening was a colored pencil depiction of Edgar Cayce's face from the cover of ARE 's *Venture Inward* magazine. "And who is it?" Weatherford said. David replied, "Edgar Cayce," although he had never seen a picture of Cayce since. "Yeah, but who else does it look like?" Weatherford asked. David acknowledged that it was extremely similar to his own face, but refused to believe that it meant anything.

David used the ARE volunteer lodging listings to find his first rental in Virginia Beach with Linda Cornett. Linda's house ended up at Old Great Neck Road, which was right off Great Neck Road. Amazingly, the other man who was subletting at the time, Dennis, was a collector of German steel helmets. The next day, David remembered that his reading said "Big Neck" and grabbed a book of transcripts and sat on the couch to try to find out if there were any other examples of prophecy.

Before he could even look at his transcripts, his eyes wandered to the library where he saw a book titled "*History of German Steel helmets: 1921–1945*". Dennis didn't even look at the house until August and did *n't* move in until September, although the German phrase was heard in July. In December, he learned that his entire helmet collection had been stolen from a warehouse in his hometown.

Across from Linda was a fairly high-ranking ARE employee. He heard about David and wanted to meet him right away, marveling at the facial resemblance. He later met with his boss at Nawab Indian Restaurant with him and David, and at the end of the dinner, the boss told David that he "*almost fell backwards*" when he first saw the resemblance of David's face to Cayce. David was still in denial to fully believe that there was a connection with Edgar Cayce at this point.

The owner of a large business dedicated to Cayce's work saw David and, not knowing anything about him, said to his friend, "*My god, he looks just like Edgar Cayce!*" Later, the man asked David for a reading to show "proof" and became angry when the reading reprimanded him for illicit sexual activity. He then did not support David's case.

David confronted his readings on the issue of reincarnation on November 27, 1997 and they confirmed that it was true and "with this knowledge comes responsibility - a great responsibility". They told him that "*this time it is not so configured for medical reading*" and should spend its time "*teaching universal concepts to the masses*". David could hardly believe what he was told and argued a bit as he read.

Soon after, David began to have specific dreams detailing various aspects of Cayce's life and gradually accepted his reincarnation as fact.

David was given the name of a well-known local psychic in the reading, as well as the exact name of her son, which was an unusual name, and warning that he may try to use drugs. His friend arranged a meeting with a woman who seemed threatened by the whole thing and said that David could not be the return of Edgar Cayce because he sometimes used profanity when he spoke and "Edgar would never do that." She was more concerned that she would lose her clientele if Edgar Cayce did return to Virginia Beach. David then stopped using profanity, a habit he learned from his father.

Through all of these experiences, David worked menial jobs until July 1998 when he became self-employed, doing readings for others.

David's friend arranged for him to meet Edgar Evans Cayce, Edgar Cayce's youngest surviving son, in January 1998. Edgar Evans was extremely rude and barely looked David in the eye. He asked David a complicated question, started to get a solid answer, and then suddenly cut David off after a sentence or two before he even had a chance to articulate his answer, and then asked another completely different question. At the end of suffering

Edgar Evans said that although he still didn't believe it, he agreed that David's case was far better than any other person he had met who claimed to be Edgar Cayce. They never spoke again.

David attended the Seeking God study group in Virginia Beach, which was occasionally attended by Charles Thomas Cayce, head of the ARE. David gave Charles Thomas a packet of prophecies, including the idea that the Arab-Israeli conflict would escalate into a "great war" and that Earth changes would continue to intensify.

David later presented a reading to the ARE that indicated that if the ARE did not take a more active stance in promoting the existence of Atlantis and the Hall of Records, then the negative forces in the Egyptian government would ensure that the discoveries and available information would never be made public. None of the proposals were accepted and ARE did not attempt to contact him.

One day that January, David decided to cast a comparison chart between Edgar Cayce's birth date and his own. He was shocked to see the similarity between the two graphs. All the inner planets were in almost exactly the same positions in both charts and the outer planets were in almost perfect aspects to each other such as square, trine and sextile.

He later realized that both he and Cayce were born in the year of the Ox in the Chinese zodiac, and that the cusp or "balance points" of the two charts were in perfect 180-degree opposition.

In February 1998, David deliberately avoided taking on new gigs for three weeks and put together his first edition of his book called "Convergence". The book summarizes David's years of scientific research into Atlantis, the Global Grid, Ascension and extraterrestrials. It was published on the Great Dreams website in March 1998 and received great public acclaim.

David realized that his former roommate Eric was the reincarnation of Edgar's closest friend, David Kahn. Later

he discovered that his college friend Chris was Morton Blumenthal, Edgar's main financial backer. Morton's brother Edwin reincarnated as David's high school friend Jude. Edgar's original estranged business partner Dr. Wesley Ketchum reincarnated as David's brother Michael, even wearing glasses of the same style.

Edgar's father returned as David's father, wearing the same mustache and only buying clothes at the "Squire Shop". Cayce's father was known to all as "the squire." Edgar's wife Gertrude reincarnated as David's friend Angelica. In all these cases there are striking similarities of face and character, as well as bold indications from the readings which pointed to their relations.

After the 1929 crash, Edgar and Morton had a major dispute, after which Morton stopped funding the Cayce Hospital. Chris, Morton's reincarnation, came to live with David in Virginia Beach on 70th Street, just three blocks from the ARE. As a result, when David was due to revisit the hospital for the first time in his life to formally plead his case to the ARE, he and Chris had the most important fight of their entire friendship.

After David presented his case involving pictures, astrological charts, and many of the psychic stories listed above, the ARE worker who had his case said he didn't look like Edgar Cayce, astrology "didn't mean anything," and "a lot of people come here, across the country with great-sounding psychic stories like yours, all convinced they're Edgar Cayce."

David also presented this man with a manuscript copy of The Convergence, his first effort to bring together his scientific material on Atlantis, the Great Pyramid, the Global Grid, and a scientific method to confirm the idea that the Earth is undergoing an energetic transformation, supported by new, unique research from reading Edgar Cayce and others resources. You are a man

he soon read the manuscript and said it was "nothing special" and that he didn't believe any of it.

Later, David found out through the grapevine that he had been harshly judged for using marijuana, and the opinion was, "*If he's Edgar Cayce, he's young, nervous and inexperienced to be of any use to us useful, and his former drug use makes him too political sensitive to being exposed to our members.*" Instead, an ARE worker got David, who was selling candy at the concession stand, to ARE's production of Man of La Mancha.

This was how this man "introduced David to the public."

Shocked and disgusted by the way he was treated, David cut off all contact with the man after the game ended and has rarely visited the ARE since.

Joseph Myers confirmed in late 2001 that the ARE board still had a standing policy of completely ignoring David, avoiding positive or negative press about him, and hiding his existence from its 20,000 members.

On July 1, 1998, David received data from dreams, visions, and readings that New York could be attacked by a portable nuclear bomb on August 17, 1998. Extreme details were given about the astrological configurations of that particular day, which turned out to be remarkably correct. His psychic description of the man in question clearly shows in hindsight that he was Bin Laden.

He was told that he had to act on this prophecy because it would disrupt the spiritual progress of the entire world if it actually happened. David called the FBI with all the details and they began frantically tapping his phone less than a week later. To this day, David is still under surveillance where when he says certain key words he hears a click, which means he is being recorded.

Less than two weeks after David received this data, Bin Laden bombed American embassy buildings in two foreign countries, beginning to confirm the accuracy of the prophecy.

Surprisingly, *it turned out that August 17 was the exact day Clinton first admitted to the world his affair with Monica Lewinska — in New York.* Grand Central Station was closed due to "terrorist threats". Two days later, Clinton bombed Sudan and Afghanistan over previous embassy bombings and in retaliation for "*an undisclosed major terrorist attack planned against*

to the United States, confirmed by multiple sources".

In the same July 1, 1998 reading on this issue, David received a prophecy that said, "*The bombing of World Trade*

The Center really rocked in 1993. There will be more next time a more serious problem if the planners get their act together." Data on these synchronicities has been published on the Great Dreams website.

David started his psychic reading business in mid July 1998. Literally in a week he had enough clients to support himself financially. He charged the client \$60 at the time.

David's third client didn't talk to him or tell him anything about herself when she came in, so David just started reading without any conversation. David's reading went into great, specific detail about the problems she was having with her health and marriage and what to do about them. When he woke up from his trance, she was crying.

In early 1999, David was able to follow the directions of his readings and set up an online website <http://ascension2000.com> , where he presented his scientific research, articles, readings and dream interpretations. The site

David realized that he had been having dreams about his clients the morning before he was supposed to do their reading. The dreams had extremely detailed information about the clients' problems. This led David to start offering "Dream Readings" from his website where a client could talk to David on the phone for at least an hour in a "pleasant" conversation, then David would receive a dream for the person and then a Psychic Reading on audio tape and a 15 minute follow up interview after receiving a reading. Its initial rate was

80 dollars, then 100, and finally 150. He made enough money from it to make a living.

Without exception, every dream reading that David performed on his clients was remarkably accurate and picked up a lot of data that he had not consciously told him.

One man was flying to California to apply for a new job and wanted to know if it was a good idea. David's dream went into extremely specific detail, including the structure and mirrored appearance of the building, its location by a body of water with a small footbridge, the yellow excavator seen outside the building, what the woman interviewing the man looked like, sounded like and acted like. like what food the man would be served, what the office looked like, what the bathroom looked like, and that he would walk through a party on his way out.

At the end of the dream, a monster that looked like a combination of Godzilla and a hippo came out of the lake and completely destroyed the building. The man was so shocked at how exactly David's dream came true that he was very concerned about the prophecy of doom and booked a flight out of California just hours after leaving the interview in a hurry. The business he applied for ultimately collapsed in the dot-com crash of 2000-2001.

Another dream reader client contacted David and told him about her frequent UFO experiences, which often occurred at night and were very intense in nature, featuring pulsing sounds and light outside her bedroom window, alien presences coming into the room and giving her messages etc. The night David read her dreams, she had another of her experiences.

A UFO appeared outside the window with a bright light and a pulsating sound, and a man in a robe of light who looked like David appeared in front of her. It was the first time a human being had appeared before her in such a vision, and she was convinced that it was David as his Atlantean incarnation Ra-Ta. The man said to her, "Remember the giant cathedral," and she wrote it down. The next day she cried on the phone when David went into detail about his dream for her,

where he was imprisoned inside a giant cathedral. She didn't say anything to David until he began to describe his dream to her.

David had another client who was told in a dream that she was a Mayan priestess in a past life. Her husband was unwilling to perform the rites of human sacrifice, so he was killed. After he died, they astrally projected into the bodies of dolphins and whales to enjoy each other's company, but it still wasn't enough for the man who longed to be back with her.

After retrieving the tape, she calls him and tells him about a dream she had two years ago where she was frolicking in the ocean as a whale with another whale named "Elelaka". She eventually left the water and turned back into a human, causing "Elelaka" to be sad. She responded to his protests by saying that "I have to go take care of the kids." No dream analyst could figure out exactly what this dream meant, but David's bizarre past life story explained it perfectly.

In another dream reading case, David's client Marshall Dudley woke up with a dream in which he had trouble setting up his tripod. Still remembering his dream, he went outside, found David's tape in the mailbox and listened to it. David's dream also represented a person having trouble setting up a tripod.

Once the reading began, after one standard opening statement, it began with, "Tripod presents..." and so on. Marshall was so impressed that he paid for David to fly to Knoxville, Tennessee to give a lecture and workshop at Pellissippi State University, Goins Auditorium. It was David's first lecture abroad and it was well attended.

In January 1999, David became friends with Dr. Hideo Izumoto, a Shinto teacher and acupuncturist, whose angelic guidance informed him that David was the reincarnation of Edgar Cayce. David had never told Hide anything about such a connection and he was glad he did

the psychic independently verified his reincarnation without being precharged.

David had a dream where the maladaptive part of his personality was supposed to be "killed" by a person wearing a clown wig whipping him with a bright light. When he awoke and dictated the part about the strange attack, still feeling the residual fear of the dream, the clown wig on the shelf in his closet spontaneously jumped off the shelf and fell to the floor, causing David great dismay at first and then great amazement. This was the most dramatic of an ongoing series of telekinetic events - which always occurred in a way that left open the possibility that they were 'coincidences'.

In another example, David had a dream where his old marijuana friend had openers on his hand and was very sad. David told him he could still pick things up if he put his hands together. The friend was so excited that he slammed both can openers very hard.

At the exact second the can openers connected, David was awakened by a crash in his room. A clip-on light next to his bed fell from the windowsill, symbolizing the "death of light". Three days later, David learned that his friend Chris was involved in a very illegal activity at that exact time on Friday night. Chris eventually rehabilitated himself from alcoholism in the early 2000s with David's continued counseling.

In July 1999, David received two cryptic sentences that said: *"The Vice President claims this as his own authorship without he would realize that he is completely naked. He will decide the next winner transition period."* The quote was posted in two different places on the Internet.

More than a year and a half later, David realized that this was a prophecy of the 2000 election crisis, when Gore thought he could "win" the presidential election by ordering a recount in Florida. Reading suggested he never had a chance to win because the political elements in Florida were on Bush's side, leaving Gore "completely naked".

In 1999, David was stopped by his companion Sabrina as he was transcribing his dreams and readings to tell him a story. At this point, David was about three months behind on the transcript. She visited the ARE over the weekend and met a man who showed her pictures of a building where the top floor was designed to look like a UFO. David continued transcribing right after Sabrina told him to, and less than a minute later the dream was describing a building where the top floor was designed to look like a UFO.

David called Sabrina into the room and immediately played the tape for her and they were both amazed. This is just one example of many where David's transcripts referred to events that had just happened in his life, regardless of when the actual dreams or readings were done. Again, every time David sat down to transcribe, this happened – it was the norm, not the exception.

In January 2000, world-renowned psychic Uri Geller also confirmed that David was the reincarnation of Edgar Cayce and published it on his website.

Also in January 2000, David discovered the "Wilcock constant", a single number that is the common denominator for every planetary and solar orbit in the entire Galaxy, down to the second. He was literally "on fire" because of it, and just 24 hours later the house burned down just 15 feet from his own next door. Cayce also had several occasions where his houses burned down - one occurred while he was sleeping on a couch, and the couch appeared to be the cause of the fire.

In May 2000, David moved to his current residence. An acquaintance of his needed a place to stay and David ended up hosting him longer than he thought was appropriate. David finally confronted the man and told him he had to leave. The day after the man left, a giant tree came crashing down in David's yard over the exact spot where the man's car was parked, which the man spent most of the day working on. If he hadn't left 24 hours before, the car would have been completely destroyed. David's landlord still hasn't replaced the shed,

which was destroyed by this falling tree, which wasn't even a hurricane, just a fairly heavy downpour.

In late 2000 and early 2001, David had a series of dreams that compared a plane crash to a sudden economic collapse. These were released alongside figures that warned of an economic crash by the summer of 2002, precipitated by "a series of unforeseen catastrophic difficulties" in America. An amazing series of symbolic experiences, psychic data and readings clustered around 9/11, the date of the WTC / Pentagon terrorist attack, showing clear prophetic foreknowledge of the event, which David has preserved in four articles on his website.

Throughout the summer of 2001, David had dreams of houses catching fire and burning down. After 9/11, he had a massive burst of inspiration that led to the creation of *The Divine Cosmos* as a new book containing his latest research findings. Within two days of this exciting breakthrough, the house directly down the street from him burned down, as had now happened on two previous occasions when David had been really excited.

As of February 2002, David is still supported only by public donations and is completing his scientific work by completing "The Divine Cosmos", his third and final book in a trilogy that deals with this concept; the first two were "*The Shift of the Ages*" in 2000 and "*Convergence: The Physics of Ascension*" in 2001. [David resumed doing client readings in March 2002.]

David's second book was inspired by the first book's rejection letter from a major publisher. In the end, he followed the suggestions and rewrote the first book. He had a dream where he was referred to as the "father of anti-gravity" and was surprised that he didn't know anything about it. What he discovered when he started looking into it in late 1999 became so fundamental that it has now spawned two other books, and David presents the complete scientific basis for explaining how technologies involving anti-gravity propulsion and unlimited "free energy" from vacuums are already within the reach of humanity.

In December 2000, David was hired by Dr. Scott Mandelker as director of research for the grant-sponsored Time of Global Shift multimedia seminar, which presented the main message of David's scientific research to cities across the United States, including a presentation with new images every 10 to 15 seconds along with the lecture.

In January 2001, David discovered the work of Dr. Alexey Dmitrieva, who convincingly demonstrated the scientific case that the entire solar system exhibits a constant increase in energy charge. This turned out to be the last piece of information that proved David's basic hypothesis correct—humanity, Earth, and itself
The Solar System is on the verge of a sudden burst of evolution, triggered by the transition of the Solar System into a higher energy region. in the galaxy.

In April 2001, David appeared twice in two weeks on the Art Bell international radio program with an estimated audience of 2-4 million people. On a second occasion on April 31, several of his friends from the East Coast "accidentally" woke up early in the morning and tuned in to the show, not knowing in advance that David was playing.

In January 2002, David published his first full article on prophecy detailing possible future events and their timelines. Time will tell if it comes true or not. Since then, more articles have been published, as well as the first volume of Divine Cosmos, which has consumed almost all of David's time and attention over the past six months.

On the exact day we first published this book, David's new Internet DSL service also launched. Since David originally connected to the Internet in 1995 at 2.2 Kbps, this in itself represents a "vibration increase" and moved the connection speed from 26.4 Kbps to 1.544 Mb/s.

"We believe that the Earth today is on the verge of a critical transformation in both its physical form and its energy body - a shift that has long been predicted around the world."
